- 3. Have you, in your experiences, seen where an organization, a band, or a family fractured?
 - a. What do you understand to be the cause(s)?
 - b. Have you ever seen or heard of restoration or renewal of those?
 - c. If so, what brought them back together? If not, why not?
- 4. Why was the kingdom split, what would you say are the reasons that were foundational to this messy squabble which ultimately created two nations?
