## **New Student Admissions Procedure**

Attend an open house or schedule a tour. Prospective students are welcome and encouraged to attend on January $25^{th}$ from $10$ am to $12$ pm or to schedule a school day tour online.
<b>Schedule a school day visit</b> : All prospective students must visit the school and meet the director and teachers to be considered for admission. <i>A current grade classroom shadow day is required for entering</i> $2^{nd} - 6^{th}$ <i>graders.</i> During a shadow day visit your child will take part in all classroom activities.
<ul> <li>Apply: Complete and submit the entire Application packet (student information, parent questionnaire, and signed financial agreement). Submit with your non-refundable \$75 Application Fee (waived for siblings of current students) to 366 Gault Street, Santa Cruz, CA 95062.</li> <li>Priority Admissions Application Deadline: February 28th, 2020. Priority consideration is given to applications received by this date.</li> <li>Rolling Admissions: Applications received after the February deadline will be evaluated and admission offered on a space available basis.</li> </ul>
If applying for a <b>scholarship</b> , <i>please contact us to request a scholarship application</i> . Please turn in <i>with</i> your admissions application. Returning students and siblings are given priority consideration and then scholarships are offered on a first come first serve basis based on remaining funds available. About 25-30% of SCCS students are on reduced tuition each year.
Keep this list and a copy of your application for your records.
<b>School Review:</b> All applications will be reviewed and considered following a school visit by your prospective student(s).
<b>Notification and Wait Lists:</b> Applications will be evaluated when all steps are complete and all materials have been received. All applicants will receive email notification of the school's decision including an offer of acceptance, a scholarship offer (if applicable), an ACH form, and a records request for (if applicable). For applications turned in by the February 28th deadline, notification of acceptance will be sent via email, by mid-March. If space is not available at the time you have applied, and your student has met the admissions criteria, your application will be kept active on our waitlist for the school year and you will be notified if space becomes available.

(drop in, paid for by the minute)

Tuition covers books, in-school supplies, morning care from 8-8:30am, and most field trips. Some events and field trips, including the annual upper-class overnight trips, are subject to an additional charge.

### **Tuition Payment Plans**

A down payment of **\$1,200** is due at time of registration. This will hold your child's place in the school. This payment is *non-refundable*. The deposit is applied to the tuition for the 2020-2021 school year.

- **Annual Plan**: Tuition balance paid in full by August 1<sup>st</sup>, 2020. (\$225 discount for full \$11,250 payment made by August 1<sup>st</sup> deadline.)
- **Biannual Plan**: Tuition balance withdrawn in two installments, August 1<sup>st</sup>, 2020 and January 2<sup>nd</sup>, 2021.
- **Monthly Plan**: Ten equal payments of remaining tuition balance are processed on the 1<sup>st</sup> day of the month, **August through May**.

Biannual, monthly payments, and after care fees are withdrawn via **Automatic Clearing House (ACH)**. <u>A signed ACH agreement is due with the deposit</u>. *Please note, a returned check/NSF fee of \$20 may be automatically withdrawn to cover bank fees following failed transactions.* 

#### **Scholarships**

There are three main payment plan options outlined in the application to help make paying the tuition more manageable for families. As a very small, non-profit school we rely on most families paying the full tuition to pay teacher salaries and operating costs. However, if SCCS is the perfect fit for your student we do not want the tuition to put a hardship on your family. It varies each year depending on enrollment, hiring needs, volunteer commitments, and anticipated expenses but we are able to offer a limited number of scholarships for families in need each year. Current students and siblings of current students are given priority. **Please contact us to request an application and submit with this packet.** 

#### **Co-op Teaching/Parent Involvement**

The tuition at Santa Cruz Children's School is one of the most affordable in the county in large part because of our amazing community of parent volunteers. The parents of Santa Cruz Children's School students place a high value on education and many are educators themselves. As an SCCS parent you have the opportunity to design and implement unique and creative curriculum bringing your passions and expertise to the students. If you are interested in a volunteer co-op position, please let us know as soon as possible. We

have limited positions available and cannot guarantee a space to all who express interest. **Live Scan fingerprint background checks are required and will be provided**. There are also many other opportunities to volunteer and stay involved without the time commitment of a co-op position.

### **Tuition Refund Policy**

Tuition and other charges are paid and made to ensure a place in the school for the student and not for a period of attendance. Regardless of payment plan arrangements, *registration is a contract agreement to* pay the tuition for the entire school year. However, we understand there are unavoidable circumstances that may require early withdrawal. Eligible circumstances include but are not limited to job loss, moving outside of the county, medical or mental health situations, behavioral dismissals, etc. June 30th is the deadline to withdraw registration and receive a refund of any prepaid tuition (excluding the nonrefundable down payment and fees) / to stop the first tuition payment, automatically withdrawn on August 1st. Beginning on **July 1**st, we require a written notification and explanation of withdrawal a minimum of **one** *month* in advance to be eligible for a tuition refund. In circumstances where a refund is offered by the school, *tuition is payable through the month following the month of notification*. (Example: Notification submitted September 1st, October tuition still due on October 1st. Notification submitted on October 1st, November tuition is still due on November 1st). Prepaid tuition may be refunded based on a monthly payment plan schedule (minus the discount if paid in full). There is no refund for any withdrawal after April 1st, 2021. There is also no refund for extended periods of absence during the school year. In the case of the student's withdrawal or dismissal, regardless of the timing or reason, the parent is responsible for all tuition payments that are due prior to the date of withdrawal or termination. Santa Cruz Children's School reserves the right to dismiss a student at any time following a conference with the parents and upon notification by the school's directors. The refund policy applies in instances of dismissal. Refund eligibility is forfeited in the instance of false or misleading application information. Delinquent tuition payments may result in suspension or expulsion of student(s) and nonpayment may necessitate a 3<sup>rd</sup> party to guarantee payment.

#### **After School Care**

After-school care is available from 2:30 - 4:00 pm. The cost of after-school care is \$7.50 per hour. We have a flexible program and you pay only for the time you use. There will be a late fee of \$0.50 per minute for pickups after 4:00pm.
