2021-2022 New Student Admissions Procedure

- □ **Schedule a virtual or in-person tour.** On campus tours this year are offered on weekends. You may also schedule a video conference meeting. Prospective students are welcome to attend.
- □ Schedule a time to meet the director: All prospective students must meet the director and, if possible, their potential teacher either virtually or in person to be considered for admission. For students entering grades 2nd through 6th a virtual shadow day over Zoom may be required as inperson shadow days are not currently permitted.
- □ **Apply**: Submit the following to apply for a spot at Santa Cruz Children's School (submit one application per student):

 - Copy of student's **birth certificate**
 - Copy of most recent **report card**/evaluation from previous school if applicable
 - *\$75 Application Fee* (waived for siblings of current students.)

Priority Admissions Application Deadline March 12th, 2021.

Priority consideration is given to applications received by this date. Applications received after the March deadline will be evaluated and admission offered on a space available basis.

- □ If you are applying for a **scholarship**, turn in the scholarship application as soon as possible (*contact us to request an application*). Applications must be turned in before acceptance notices are sent to be considered. Returning students and siblings are given priority consideration.
- □ **School Review:** All applicants will be reviewed and considered following a school visit and submission of application.
- Notification and Wait Lists: All applicants will receive notification of the school's decision. For applications turned in by the March 12th deadline, notification will be sent via email, no later than March 26th. If space is not available and your student has met the admissions criteria, your application will be kept active on our waitlist for the school year and you will be notified if space becomes available.
- □ **Deposit:** Once your application is accepted and space is offered, submit the following within <u>5</u> <u>days*</u> to secure your student's enrollment:
 - Non-refundable check for **\$1450** (\$1200 down-payment and \$250 new student registration.)
 - Completed ACH Tuition Deduction Authorization form

*If we do not receive all of the above within 5 days your spot may be offered to another student and you will be placed on the waitlist if there is no longer room.

Tuition covers books, in-school supplies, morning care from 8-8:30am, and most field trips. Some events and field trips, including the upper-class overnight trips, are subject to an additional charge.

Tuition Payment Plans

Upon acceptance to Santa Cruz Children's School, a down payment of **\$1,200** and a new student registration fee of **\$250** is due to secure your student's place. <u>This payment is *non-refundable*</u>. The \$1,200 downpayment is applied to the tuition balance for the 2021-2022 school year. Mid-year enrollments may be eligible for a prorated tuition reduction.

- **Annual Plan**: Tuition balance paid in full by August 1st, 2021 or for enrollment after August 1st, immediately upon enrollment. (*\$225 discount for full \$11,250 payment made by August 1st deadline. Reduced tuition not <i>eligible for discount.*)
- **Biannual Plan**: Tuition balance withdrawn in two installments, August 1st, 2021 (or first day of enrollment) and January 2nd, 2022.
- **Monthly Plan**: Ten equal payments of remaining tuition balance are processed on the 1st day of the month, **August through May**, or if enrolled after August 1st, the first day of enrollment and then each 1st of the 9 months after that date until paid in full.

Biannual, monthly payments, and after care fees are withdrawn via **Automatic Clearing House (ACH)**. <u>A</u> <u>signed ACH agreement is due with the deposit</u>. *Please note, a returned check/NSF fee of \$20 may be automatically withdrawn to cover bank fees following failed transactions.*

Scholarships

There are three main payment plan options outlined in the application to help make paying the tuition more manageable for families. As a very small, non-profit school we rely on most families paying the full tuition to pay teacher salaries and operating costs. Tuition Refund Policy

Tuition and other charges are paid and made to ensure a place in the school for the student and not for a period of attendance. Regardless of payment plan arrangements, *registration is a contract agreement to pay the tuition for the entire school year*.

We understand there are unavoidable circumstances that may require early withdrawal. Eligible circumstances for a tuition may include job loss or other significant income loss, moving outside of the county during the school year, medical conditions that prohibit school attendance, and dismissal from school. **June 30**th is the deadline to withdraw registration and receive a refund of any prepaid tuition (*excluding the nonrefundable down payment and fees*)/ to stop the first tuition payment, automatically withdrawn on August 1st. Beginning on **July 1st**, we require a written notification and explanation of withdrawal a minimum of *one month* in advance to be eligible for any tuition refund. In circumstances where a refund is offered by the school, *tuition is payable through the month following the month of notification*. (Example: Notification submitted August 31st, last tuition payment due September 1st. Notification on September 1st, last tuition payment due on October 1st.). Prepaid tuition *may*, under certain exceptional circumstances, be partially refunded (minus the discount if paid in full). There is no refund for any withdrawal after April 1st, 2022. There is no refund for periods of absence during the school year. In the case of the student's early withdrawal or dismissal, regardless of the timing or reason, the parent is responsible for all tuition payments that are due prior to the date of withdrawal.

Santa Cruz Children's School reserves the right to dismiss a student at any time following a conference with the parents and upon notification by the school's directors. The refund policy applies in instances of dismissal.

Refund eligibility is forfeited in the instance of false or misleading application information, including but not limited to immunization status. Delinquent tuition payments may result in suspension or expulsion of student(s) and nonpayment may necessitate a 3rd party to guarantee payment.

COVID-19 Refund Policy: Extended periods of quarantine, shelter-in-place orders, school shutdowns, or any other *circumstances due to the COVID-19 pandemic that necessitate a shift to online or remote learning only is NOT grounds for a tuition refund* and all payments are due until the tuition balance is paid in full, regardless of participation in remote learning options.
