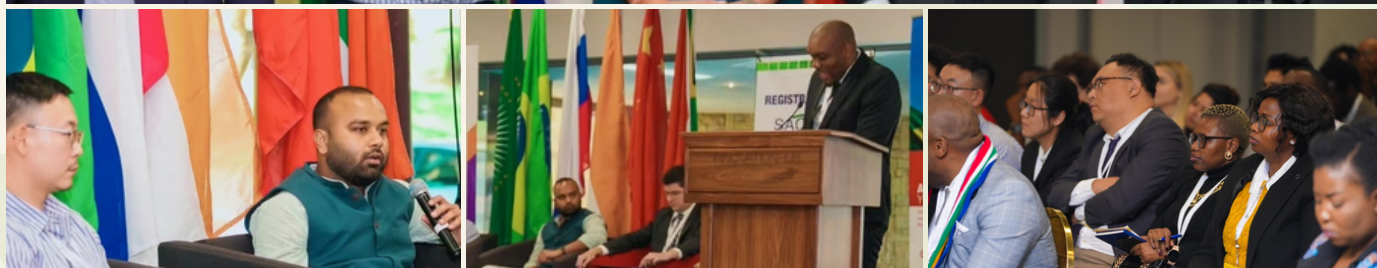

To celebrate South Africa Youth Month, the South African BRICS Youth Association (SABYA) in collaboration with the National Youth Development Agency (NYDA) and the Innovation Hub organized the **2nd Africa BRICS Youth Forum**, from 26-28 June 2023 in Pretoria, South Africa.

The Africa-BRICS Youth Forum is held annually to promote cooperation and intercultural communication between young leaders from Africa and the BRICS countries. It provides an excellent opportunity for young African and BRICS leaders between 18-35 years old to engage in discussions on global issues, share their perspectives and strengthen the multilateral relationship between Africa and BRICS. The Forum witnesses participation from Young community leaders, youth activists, entrepreneurs, change agents, researchers, and academicians.

The forum aims to establish and strengthen multilateral relations between the African continent and the BRICS countries. In line with SABYA's mission to strengthen connectivity, institutional cooperation, and people-to-people exchanges in the BRICS countries, the forum aimed to provide opportunities for youth to engage meaningfully in BRICS relations from an African perspective and to promote cooperation and intercultural communication between African and BRICS youth. As South Africa has taken BRICS Presidency in 2023, SABYA seeks to engage young people in discussions on the key issues facing African and BRICS youth to ensure that key issues and solutions are presented to relevant stakeholders.

BRICS and Beyond News

BRICS Foreign Ministers' Meeting

The BRICS Ministers of Foreign Affairs and International Relations met on 1 June 2023 in Cape Town, South Africa. They exchanged views on major global and regional trends and issues. They reaffirmed their commitment to strengthening the framework of BRICS cooperation under the three pillars of political and security, economic and financial, and cultural and people-to-people cooperation

upholding the BRICS spirit featuring mutual respect and understanding, equality, solidarity, openness, inclusiveness, and consensus.

Indian Minister of External Affairs Subrahmanyam Jaishankar said the gathering must "send out a strong message that the world is multipolar, that it is rebalancing and that old ways cannot address new situations".

The two-day meeting witnessed discussions on various issues, including local currency trading and a peace plan for the ongoing conflict between Russia and Ukraine. The meeting, hosted by South Africa, will pave the way for the 15th BRICS Summit scheduled to take place in August, which will bring together leaders from the member countries, including Prime Minister Narendra Modi, Russian President Vladimir Putin, and Chinese President Xi Jinping.

BRICS meet with 'friends' seeking closer ties amid push to expand bloc



Senior officials from more than a dozen countries, including Saudi Arabia and Iran, were in talks on forging closer links with the BRICS bloc of major emerging economies on June 2, 2023, as it met to deepen ties and position itself as a counterweight to the West.

BRICS is considering expanding its membership and a growing number of countries, have

expressed interest in joining.

Iran, Saudi Arabia, the United Arab Emirates, Cuba, the Democratic Republic of Congo, Comoros, Gabon, and Kazakhstan all sent representatives to Cape Town for the "Friends of BRICS" talks, an official program showed.

Egypt, Argentina, Bangladesh, Guinea-Bissau and Indonesia were participating virtually.

Bangladesh formally applies for BRICS membership

Bangladesh has formally requested to join the BRICS coalition, consisting of Brazil, Russia, India, China, and South Africa.

The request was put forward following a meeting between Prime Minister Sheikh Hasina and South African President Matamela Cyril Ramaphosa in Geneva.

It is noted that the South African leader supported the decision of the Prime Minister of Bangladesh.

To date, Bangladesh is part of the "Friends of BRICS". In early June, a meeting of BRICS+ foreign ministers took place in Cape Town. During the event, representatives of the South Asian country declared Bangladesh's readiness to become part of the economic bloc.

Bangladesh has already become a member of the New Development Bank (NDB), set up by BRICS in 2021, making it the first country to join the bank after its founding members.

Egypt has submitted its application to join BRICS, Russian Ambassador to Cairo Georgy Borisenko confirmed.

"Egypt has submitted its application to join the BRICS group because one of the endeavors that BRICS is currently pursuing is to shift trade to alternative currencies, be it national currencies

or a new common currency. Egypt is very much interested in that," the envoy said in an interview with TASS.

According to him, Egypt is eager to boost trade and economic cooperation with Russia. "New payment mechanisms are being created for trade transactions," the ambassador added.

New Development Bank Issues 8.5-Bln-Yuan Bond on China Interbank Bond Market

The New Development Bank (NDB) has issued an RMB-denominated bond of 8.5 billion yuan (about 1.2 billion U.S. dollars) on the China Interbank Bond Market, the bank announced. It is the bank's biggest RMB bond issuance to date.

The net proceeds from the sale of the bonds will be used to finance infrastructure and sustainable development activities in the bank's member countries, the NDB said.

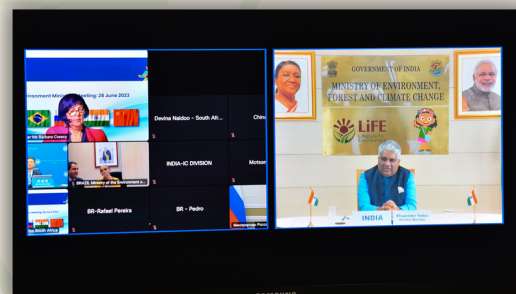
"In order to support our operations, the NDB seeks to increase its presence in local capital markets of our member countries by issuing and lending in local currencies, including the China Interbank Bond Market," said Leslie Maasdorp, vice president and chief financial officer of the NDB.

The Ninth (9th) BRICS Environment Ministers Meeting

The ninth BRICS Environment Ministers Meeting was convened on 28th June 2023, wherein the Environment Ministers of the Federative Republic of Brazil, the Russian Federation, the Republic of India, the People's Republic of China, and the Republic of South Africa participated. The meeting was held under the theme of, "Advancing Environmental Cooperation amongst BRICS towards the attainment of the 2030 Agenda for Sustainable Development," through video conferencing.



Representing India, the Union Minister of Environment, Forest and Climate Change, Shri Bhupender Yadav stated that the Implementation Plan of the BRICS Environment MoU signed in July 2018 can be a platform for exchange of knowledge, information, ideas, best practices, etc. among the BRICS nations.

Shri Yadav called upon the BRICS nations for urgent concrete climate actions, and to intensify the efforts for saving the planet. He urged that finance and technology partnerships are the key pillars for the BRICS Nations to foster greater efforts to combat climate change and to protect biodiversity while joining hands for ensuring environmental justice; climate justice; fair, just and inclusive transition.

1. Firm plans over N1b CSR investment

As part of its Corporate Social Responsibility efforts, MTN Foundation has said that it would be investing about a N1billion to upgrade not fewer than 40 Primary Healthcare Centres (PHCs) across the country under its ‘What We Can Do Together Initiative’. According to the Executive Secretary, MTN Foundation, Mrs Odunayo Sanya, MTN Foundation does not assume that it knows what a community wants as many corporate bodies that have assumed they knew what a community needed at a point in time had built projects that ended up with little or no impact on the people.

At the unveiling of the project, in Lagos, Sanya said there are 30,000 PHCs in Nigeria, adding that less than 25 per cent of them are functioning. From inception to date, Sanya said that MTN Foundation has invested about N25 billion in different projects, adding that, for the fifth phase of the project, the Foundation will be investing over N1 billion to ensure that Nigerians at the community level, have access to quality healthcare services. She called on more corporate organisations to come into the space.

2. Squamish Chamber calls for corporate responsibility from FortisBC

The Squamish Chamber of Commerce released a letter acknowledging the potential economic growth of the Eagle Mountain - Woodfibre Gas Pipeline Project but also calling for “corporate responsibility” from FortisBC to address the risks. Christopher Fehr, the executive director of the chamber, penned a letter outlining some of the positives and challenges associated with the project. Among the positives included employment opportunities as well as “stimulating local businesses and contributing to regional energy security. “However, Fehr also wrote there were risks of putting pressure on the housing supply, local workforce and municipal infrastructure.

“This is an opportunity for FortisBC to set an example of what corporate social responsibility is. While the project timeline is five years, the positive impacts to the community can last a lifetime.”

Fulton Bank's Corporate Social Responsibility Report discusses environment, volunteerism. Fulton Bank employees spent more than 13,500 hours volunteering in their communities in 2022, and the bank made more than \$6.6 million in charitable contributions, according to Fulton's Corporate Social Responsibility Report. It also helped manage manure, proving that "Going green" is not just about LED lights and recycling. The report for 2022 reflects on how the Lancaster-based bank pursues social goals and makes money. Fulton Financial, parent company of the bank, had record operating earnings of \$1.76 per share in 2022.

"It is because of that solid performance that we were able to advance our environmental, social and governance (ESG) efforts," Curtis J. Meyers, chairman, chief executive and president of Fulton, said in the report.

The bank's environmental commitment includes recycling electronic waste and paper, and in 2022, it set up a group to review Fulton's climate impact. Fulton also sells ESG investment products for customers who want to invest in a "green" way. The environmental goals extend to working with farmers, an important customer base. That commitment extends beyond the boardroom, all the way to the barnyard. To the management not of money, but of manure. Fulton Bank provided funding for a "methane digester" at AR Joy Farm in Chester County. The digester diverts food waste from landfills and reduces manure odor and runoff. That project generates carbon credits and renewable energy credits that can be sold, Fulton says. On the social front, 24% of Fulton's staff consists of people of color, according to the bank.

"Our commitment to promoting diversity, equity and inclusion is at the heart of Fulton's values," according to the 35-page 2022 report.

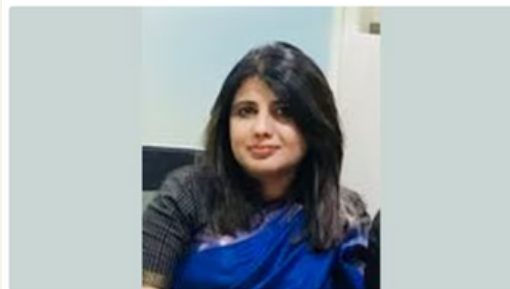

WHAT ROLE DO YOU SEE BRICS PLAYING IN SHAPING GLOBAL SOCIAL DEVELOPMENT AGENDAS AND INFLUENCING INTERNATIONAL POLICIES IN THE FUTURE?

As BRICS consists of some of the fastest growing & developing economies, its policies and decisions can & will create a long lasting impact on citizens of its member countries. In today's world, every policy decision made by BRICS will play a vital role in directly or indirectly altering the economic, political and social development goals or agendas of their respective countries.

WHAT ARE YOUR FUTURE PLANS AND ASPIRATIONS FOR WOCKHARDT FOUNDATION? ARE THERE ANY NEW PROJECTS OR AREAS OF FOCUS THAT YOU PLAN TO EXPLORE?

The mission of Wockhardt Foundation is 'To work towards and fight for the upliftment of the poor, weak and needy' and as such all future plans & programmes will continue to revolve around this mission. All our initiatives are undertaken to provide maximum benefit to the underprivileged.

2 of our new initiatives are Hunger Project & Online Skills.

The Hunger Project aims to reduce hunger prevalent among the poor in Mumbai. We provide 1 nutritious, freshly cooked meal to the beneficiaries in orphanages & slums. Over 20,000 meals have been distributed till date.

Online Skills (an extension of our ongoing programme - Wockhardt Skills Development Institute) aims to develop & offer vocational courses that cater to a wide variety of jobs across different industries / sectors.

WOCKHARDT FOUNDATION HAS BEEN INVOLVED IN VARIOUS INITIATIVES ACROSS HEALTHCARE, EDUCATION, AND OTHER SOCIAL SECTORS. WHICH PARTICULAR PROJECT OR ACCOMPLISHMENT ARE YOU MOST PROUD OF AND WHY?

The project that I am most proud of is Wockhardt Foundation's flagship healthcare initiative, Mobile 1000 which provides doorstep delivery of free primary healthcare to people living in the remotest and rural parts of India. Each Mobile 1000 van has a doctor, driver and pharmacist and is equipped with medicines, diagnostics and consumables. It covers the ADCR formula of Awareness, Diagnosis, Cure and Referral. During the last financial year (2022-23), over 3.6 million patients benefitted from the 211 vans that were operating in 20 Indian states and 1 union territory covering 4171 villages in 100 districts.

WOCKHARDT FOUNDATION HAS BEEN INVOLVED IN VARIOUS INITIATIVES ACROSS HEALTHCARE, EDUCATION, AND OTHER SOCIAL SECTORS. CAN YOU PROVIDE US WITH A SYNOPSIS OF THE WORK YOU HAVE DONE SO FAR?

Besides the Mobile 1000 initiative, Hunger Project & Wockhardt Skills Development Institute, we have various other programmes like

- **E-learning** - ensures academic excellence through quality, innovative & interactive teaching methods that provide the complete syllabus in an audio visual format for school students. E-Learning sets have been installed in 425 schools in 6 states.
- **Khel Khel Mein** - Edu Recreational Centres (toy libraries) for the underprivileged children aged 6 to 12 years. We currently have 6 toy libraries in Mumbai & Bangalore.
- **Gur+ (Dialysis centres)** - Free dialysis for poor renal failure patients. Our 3 centres in Chennai have completed over 7500 dialysis sessions in the last financial year alone.
- **Anaaj+** - Free grocery kit distribution to underprivileged families in Mumbai

ARE THERE ANY SPECIFIC INITIATIVES OR PROGRAMS THAT YOU BELIEVE SHOULD BE PRIORITIZED OR EXPANDED UPON WITHIN THE BRICS FRAMEWORK TO ADDRESS EMERGING SOCIAL ISSUES IN THE FIELD OF HEALTHCARE OR RELATED SECTORS?
