Below is a categorized breakdown of efforts and focus areas identified by coalition members:

Access to Care

Ensuring individuals can effectively utilize mental health services by addressing barriers such as cost, insurance, wait times, transportation, and stigma.

• Efforts include expanding access to specialized care, medication affordability, and removing financial and logistical barriers.

Availability of Services

Expanding and improving the range of mental health services available in the community.

• Focus on increasing long-term care options, neuroaffirmative services, and local psychiatric facilities, as well as addressing gaps in specific populations' needs.

Community & Peer Support Networks

Building grassroots, community-driven, and peer-led support systems for individuals and families impacted by mental health challenges.

 Initiatives include veteran support groups, addiction recovery networks, bereavement support, and culturally inclusive outreach.

Continuum of Care & Systemic Coordination

Enhancing collaboration among service providers to ensure seamless transitions across different levels of mental health care.

• Work focuses on interagency coordination, housing support, resource sharing, and developing standardized response protocols.

Crisis Response & Emergency Services

Strengthening emergency mental health response systems and crisis intervention strategies.

• Key priorities include suicide prevention, law enforcement collaboration, crisis stabilization, and expanding veteran-focused crisis services.

Education & Outreach

Increasing public awareness, reducing stigma, and providing mental health education for individuals, families, and professionals.

• Efforts include training on suicide prevention, overdose awareness, private practice accessibility, and mental health literacy.

Policy, Advocacy & Funding

Driving systemic change through policy reform, funding initiatives, and legislative action.

• Key areas include advocating for prescription drug affordability, securing funding for mental health facilities, and legislative engagement on mental health issues.

Research, Data & Innovation

Utilizing research and data-driven insights to improve mental health care delivery and inform best practices.

• Focus on studying mental health trends, tracking service impact, and exploring innovative care models.
