Rules

- 1. Post members and Auxiliary members in good standing have priority over non-members.

 Offering free hall rentals to friends or family is no longer allowed.
- 2. Must pay a \$300.00 security deposit, and sign the Hall Agreement to secure the hall.
 - a. \$100.00 will be returned if tables and chairs are put away and trash cans are emptied into the outside dumpster. *Plus Decorations are removed
- 3. The renter must be at least 21 years old to rent the hall. Must provide valid ID.
- 4. All events require the renter to pay for an ABC License.
- 5. VFW Post 3000 is not responsible for any loss or damage to any personal property.
- 6. It is illegal to bring in outside alcohol. It is strictly prohibited. All alcohol must be purchased from the VFW Post 3000. Giving alcoholic beverages to a minor is also strictly prohibited. Bringing water, iced tea, lemonade, or juice is allowed. Renter are to provide coolers or containers at their own cost, and they must be removed at the end of the event.
- 7. Smoking is only authorized in designated smoking areas. (Beer Garden or Outside)
- 8. The renter is responsible for any damage to the Post by themselves or their guest.
- 9. The renter must provide their security for events that require such a service.
- 10. No alcoholic beverages are allowed outdoors beyond the limits of the fenced-off **Beer Garden.**No alcoholic beverages are permitted in the parking lot.
- 11. All costs must be paid in full on the day of the event or sooner.
- 12. The renter is responsible for removing trash and overall cleanliness after the event.
- 13. Early show-up for setup/ decorating is allowed on a case-by-case basis, dependent on other events that day and personnel availability.
- 14. The event must not exceed a maximum occupancy of 150 persons.
- 15. NO CONFETTI or GLITTER ALLOWED Please
- 16. Fighting or any other disorderly conduct is not allowed; any altercation will result in the termination of the event and the loss of the Deposit.
- 17. All food items brought in must be disposed of and cleared from Refrigerator if used.
- 18. NO DRUGS ALLOWED on the Post Premises to include Marijuana. This post falls under the jurisdiction of Federal law.
- 19. The renter is responsible for informing their guests of these terms and conditions.

Any rule violations may result in the loss of the deposit and the shutting down of the event with no refund. Please be respectful of our Post so that we can continue to rent out our facilities.
