 - Click on 'Confirm Your Purchase', click 'Pay By Credit Card' and enter your credit card information
- After successfully completing the credit card transaction and being redirected to the User Profile, click on the Application Window and choose the 'Iron Co' tab
- Click on the selected application and begin the search.
- To exit the web portal: Click on the top far right orange icon (Exit the portal).
