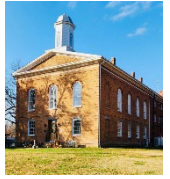

1. Return signed application with attachments to the Iron County Collector to 202 South Shepherd St. Ironton, MO 63650 or by email at taxcredit@ironcountymmo.gov by June 30th each year.

3. Applications must be renewed annually. **The renewal MUST BE returned to continue the credit.** The application deadline is June 30th, 2026
