

NOTICE OF ELECTION

In accordance with Chapter 115 of the Laws of Missouri, notice is hereby given that the General Municipal Election will be held in the County of Iron on Tuesday, April 8, 2025 at which election all registered voters residing within the County of Iron will be given the opportunity to vote.

The official ballots for the said election will be in substantially the following form:

INSTRUCTIONS TO VOTERS: To cast your vote for a candidate(s), darken the oval opposite the name of the person(s) for whom you wish to vote. You may vote for the number of candidates indicated for each jurisdiction on the ballot.

PROPOSITIONS or QUESTIONS: If you are in favor of the proposition or question, darken the oval opposite the word “YES”. If you are opposed to the proposition or question, darken the oval opposite the word “NO”.

WRITE-IN CANDIDATES: If you wish to vote for an individual whose name does not appear on the ballot but who has properly filed as a write-in candidate, write the name of the individual on the line provided and blacken the oval to the left of the write-in line.
