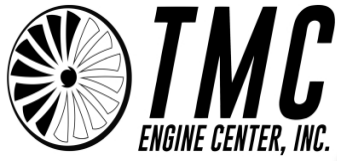
TMC NDT Services

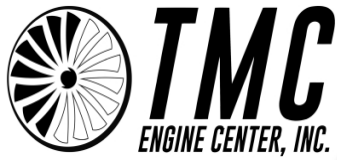
Hospital & Surgical Services

In turn, the engine is swarmed by our highly skilled technical team, where and the necessary actions are performed to get the engine in-and-out.



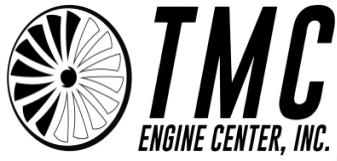
