Code of Conduct Guidelines for Players / Parents / Guardians

Players representing the Falcon Youth Rugby Club and their respective parents/guardians should abide by the following Guidelines.

Players	Parents/Guardians
Bullying behavior of any form is not tolerated on our team. We will help create and maintain safe environment following 3Rs (Recognize, Report and Refuse).	Bullying behavior is unacceptable in any form whether from a parent/guardian. We will help create and maintain safe environment following 3Rs (Recognize, Report and Refuse).
Players are expected to be properly dressed.	Do not force an unwilling child to participate in rugby.
Learn the laws of the game and abide by them.	Encourage your child to play by the laws of the game.
Make a personal commitment to keep yourself fit at all times.	Teach your child the importance of effort and teamwork, healthy habits, and physical fitness.
Never argue with the referee's decision	Help your child to improve skills and to learn a positive attitude to the game.
Control your temper on the field of play.	Set an example to your child.
Do not take unfair advantage of any player.	Applaud good play by our team and by members of the opposing team.
Hard work will benefit both yourself and the team's performance.	Be friendly to parents of the opposition.
Do not listen to comments from spectators.	Do not publicly question the referee's decisions.
Co-operate with your teammates, coach, and referee, for without them you do not have a game.	Support all efforts to remove verbal and physical abuse.
If you are disciplined, accept it without question.	Recognize and value the importance of coaches and referees.
Do not use abusive and foul language.	Do not use foul and abusive language or behavior.
Do not make derogatory comments towards players, coaching staff, referees, or visiting opposition.	Do not make derogatory comments towards players, parents, coaching staff, referees, or visiting opposition.

Team Tactics

Matters relating to team tactics are the sole responsibility of the coaches. They should not be publicly criticized by players, parents, or non-participants.

Team Selection

Will be decided by the Head Coach.

Players' Performance

Judgments of players' performances are the prerogative of the selectors. Shows of public disapproval by parents and spectators should not occur.

Discipline

All matters relating to team and individual discipline on and off the field (sidelines) are the responsibility of the team owners.

Grievance Procedure

If you feel you have a grievance with your respective program, you must inform the team owners by e-mail within 7 days of the incident/event occurring.

The team owners will respond, acknowledging receipt of the complaint.

The team owners will endeavor to deal with the complaint within 10 days of the original complaint; however, if you feel that your complaint has not been dealt with sufficiently and the process has been exhausted, it then becomes an issue for the Director of Rugby Texas who will review the complaint accordingly.

Failure of a player or parent to comply with any of the above could result in a disciplinary action, including but not limited to, player removal from the squad.

Assumption of Risk and Waiver and Release of Liability for COVID-19, other diseases, and injuries.

I acknowledge that attending or participating in rugby practices, training, clinics, competitions, or matches, whether contact or non-contact (collectively "Rugby Activity") may increase the risk of exposure to and infection from infectious diseases such as COVID-19 and that such exposure or infection may result in my and/or my child(ren)'s personal injury, illness, permanent disability, and death.

I knowingly and freely assume all risks, known and unknown, of my and/or my child(ren)'s attendance at or participation in rugby activity, including but not limited to exposure to and infection by infectious diseases such as COVID-19, even if resulting from the fault or negligence of the Released Parties. I accept the sole responsibility for any injury or infection to myself, my child/ward, and my family, including but not limited to, personal injury, disability, death, illness, damage, or loss of any kind, that I, my family, or my child(ren) may experience or incur in connection with me or my child(ren)'s attendance or participation in rugby activity.

WAIVER, RELEASE AND PROMISE NOT TO SUE.
