*Whereas* at the American Legion Auxiliary Department of Oklahoma annual convention held July 13-15, 2018 in Shawnee, Oklahoma, the governing documents were approved and were in compliance with the National American Legion Auxiliary documents; and

*Whereas* at the 99<sup>th</sup> Annual American Legion Auxiliary National convention held in Indianapolis, Indiana on August 24-29, 2019, changes were made to the National Governing documents; and

*Whereas* in September, 2020 the American Legion Auxiliary National organization updated the governing documents again effecting Standing Rules XIII Dues and Assessment Sections 1 and 5; then

*Be It Therefore Resolved* that the American Legion Auxiliary Department of Oklahoma Standing Rules XIII. Dues and Assessment Sections 1 and 5 be amended and add a new Section 7 to comply with the National documents to read as follows:

- 1. The National per capita dues shall be twelve dollars (\$12.00) per annum for Senior members, and two dollars and fifty cents (\$2.50) per annum for Junior members. The per capita dues for Senior members shall include a complimentary subscription to the American Legion Auxiliary national magazine. Each Department shall remit the national per capita dues promptly to the National Treasurer via National Headquarters at least monthly. (Effective with the 2019 membership year from the 2017 National American Legion Auxiliary Convention.)***
- 5. A member failing to pay such annual dues by January 31<sup>st</sup> of the current membership year shall be delinquent and suspended from membership privileges. A member deemed delinquent for failing to pay dues by December 31<sup>st</sup> of the current***

*Membership year shall be classified as expired. Such expired member may rejoin as an active member under **member's original join date without interruption of continuous years of membership, and membership privileges reinstated, by payment of all past dues.***

- 7. In order to allow Departments adequate time to process end of year dues payments, the second dues renewal notice shall be postmarked no later than February 1.**
