

FORENSIC SKETCHES OF EIGHT LITERARY CRIMINALS

Police sketch-artists—they call themselves "forensic artists"—are readers, of a sort; they face the same problem readers face, namely: How to conceive of a character's face? Their task is to take a text, usually a spoken description, and draw from that a person. Not a person, the person; "Have You Seen This Man?" being the eternal question of literature and law enforcement both. It is amazing how police work from so little information. And it is amazing, too, to realize how little detail the greatest writers provide. As witnesses, authors are unreliable but trenchant: just a hint here, a shade there, but from that, a life. Hester Prynne had "a marked brow"; from "ivory heel" to "slouched hat," Ahab was all "grimness." Here we've asked forensic artist Barbara Anderson to interpret the mugs of eight literary criminals, based on prose descriptions alone (plus imagination). —Joshua Cohen



FAGIN

DESCRIPTION:


"[...] a very old shrivelled Jew, whose villainous-looking and repulsive face was obscured by a quantity of matted red hair [...] As he glided stealthily along, creeping beneath the shelter of the walls and doorways, the hideous old man seemed like some loathsome reptile, engendered in the slime and darkness through which he moved, crawling forth by night in search of some rich offal for a meal."

DESCRIPTION:



DESCRIPTION:



DESCRIPTION:



DESCRIPTION:



DESCRIPTION:



DESCRIPTION:
