**RATES**

The above rates include a purchased gas cost of \$5.952 per Mcf.

**CONSTRUCTION CHARGE**

A minimum construction charge of \$ 150.00 per meter installed or housing unit served shall be made.

**DELAYED PAYMENT PENALTY**

The above schedule is net. On all accounts not paid in full within twenty (20) days of the date of the bill, 1.5 % will be added to the net amount billed.

**MINIMUM CHARGE**

The above rates are subject to a minimum Monthly Demand Charge of \$35.00.

**RECONNECTION CHARGE**

Whenever the supply of gas is disconnected by customer request and a request for reinstatement of service at the same premises is made within thirteen (13) months so as to provide service to the same household or any adult member thereof, a charge of \$35.00, per billing month or portion thereof that the service has been disconnected, will be made to restore service up to a maximum charge of \$ 455.00.
