Do I Need a Pennsylvania Commercial Registered Office Provider?

Yes, with very few exceptions. Most businesses and nonprofits that form or register in Pennsylvania must have a physical registered agent in Pennsylvania at all times. This includes keeping the agent's contact information up-to-date with the Pennsylvania Department of State - Bureau of Corporations and Charitable Organizations. This is called "maintaining" a registered agent and helps your company stay in good standing.

Who Can Serve as My Pennsylvania Registered Agent?

You may appoint either an individual or a company to serve as your Pennsylvania Commercial Registered Office Provider.

Appointing An Individual

Pennsylvania allows you to appoint a consenting individual to serve as your registered agent. Individuals must meet all of the following requirements at all times:

- The individual must be a resident of Pennsylvania.
- The individual must make available their name and street address to be included in the public records of Pennsylvania as your registered agent. The street address, called the registered office, must be a physical address in Pennsylvania. A P.O. Box or mailbox service is almost never allowed since the agent must personally sign for your document.
- The individual must be available at the address listed during business hours to sign for documents.

When deciding on your Pennsylvania Commercial Registered Office Provider, consider that individuals travel, meet with clients, and take time off. Any absence increases your risk of missing the delivery of important legal notices. A registered agent company is always available to receive documents on behalf of your business.
