Waiver and Release Agreement

I, the undersigned understand and expressly acknowledge the HAZARDOUS nature and inherent risks involved in hands-on-training being provided at the Alaska Fire Conference. I also understand and expressly acknowledge that the risks include but are not limited to bodily injury from training or being in close proximity to the training equipment, and further, that persons can be injured in normal use during the Training Activity.

IN CONSIDERATION, for the privilege of participating in the Training Activity at the 2018 Alaska Conference conducted jointly by the AFCA & ASFA, I agree to freely and expressly ASSUME AND ACCEPT ANY AND ALL RISKS OF BODILY INJURY AND HARM OF ANY KIND arising out of or related to the Training Activity. I further agree to HOLD HARMLESS and INDEMNIFY the Alaska Fire Chiefs Association (AFCA), the Alaska State Firefighters Association (ASFA), Kenai Fire Department (KFD), Central Emergency Services (CES), Nikisk Fire Department (NFD), Kenai Chapter of the ASFA, Alaska Division of Fire and Life Safety (ADFLS) the City of Kenai, the Kenai Peninsula Borough, their officers, members, conference officials, agents, representatives, and conference management parties and further RELEASES the Parties from any liability or responsibility relating to any accident, damage, injury, illness or harm of any type to me arising out of or related to Training Activity.

I further agree that neither the parties or their officers, members, conference officials, agents, representatives and conference management shall not be held responsible for any equipment or article lost, damaged, stolen or destroyed in connection with any conference activity.

I also agree that any court or trier of fact interpreting this waiver release agreement shall give effect to its whole and/or specific parts, so as to enforce this agreement regardless of any local rules of construction and that any court or trier of fact shall give effect to the intent of the Parties, even if reformation of a specific provision of the agreement is required. The undersigned further agree that this agreement to be interpreted in accordance with the laws of the State of Alaska and subject to venue in the Kenai Superior Court.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND WAIVER, AND A CONTRACT BETWEEN THE PARTIES. I SIGN IT OF MY OWN FREE WILL.
