Please have guests arrive on time, the tour will need to start at no later than 20 minutes from the party start time. Client is responsible for their guests (children and adults) at all times. Triskelee Farm parties provide an educated

farm tour. Triskelee Farm parties do **not include childcare**. Triskelee Farm will review important farm safety rules once all guests have arrived. Some rules reviewed will include; (**you can share this information ahead of time with the parents**).

- No running or screaming (this will scare the animals),
- Guests must stay with the tour guide and the group at all times.
- No wandering around the farm. We will go on a guided farm tour together. After the tour please stay in your designated party area.
- Wear close--toed shoes that you don't mind getting dirty. (expect mud and poop).
- Dress for the weather, it's cold in the barn and we go on the tour rain or shine.

**What do you need to provide?** Please bring, Food, drinks, cake, nonalcoholic drinks (water/juice), paper goods (plates, napkins, cups, tablecloths etc), decorations, games, or piñata (Client to assume all risks with the piñata).

No noise makers, loud or large flapping decorations or games are allowed.

No confetti or glitter. (you will be responsible to clean this).

No loose balloons (They must have stings attached, loose balloons and broken pieces are choking hazards. Balloons may only be used for decorations, not to be played with unless kids are taking them home at the end.).

- As the party host, you are responsible for any damages to our property caused by your guests.
- No outside alcohol or liquor on Triskelee Farm property.
- Guest agrees to abide by TF rules and regulations at all times and must be accompanied by a guide when interacting with animals.

# What to know about our parties:

**Party space includes:** four 6ft tables plus benches. Seats about 20 people or less. Two smaller tables for food or presents.

### Don't forget:

- Tape/pushpins to hang things up
- Tablecloths
- Cooler/ice
- Drinks -water/juice
- Cups
- Plates
- Flatware
- Knife to cut the cake
- Lighter & Candles
- If bringing a piñata; rope and bat. (no glitter/confetti and clean it up after)
- Balloons if you like ( NO LOOSE BALLOONS)
- Mud boots
- Trash bags for muddy shoes

### Order of events:

- (:45) Client/party parents arrive at quarter till for set up. Do not arrive too early, as there will be another party in the space.
- (:00) Guests arrive on the hour.
  - **Please remind your guests** to arrive on time so we can begin the activities as soon as possible. Late start time means less time in the barn to celebrate.
- (:15) Start the tour at the 15 min.
  - O We will need to start the tour regardless if all the guests have arrived.
  - O **Let guests know** we will be going into lots of animal enclosures to interact with them. Expect mud and poop and we go rain or shine so dress accordingly. Its best to bring rain boots or shoes you don't mind washing after and a bag to put them in.
  - Triskelee Farm parties provide a guided educational farm tour. Parties do not include childcare.
     Guests can drop off children but the client will assume all responsibility of them.
  - Triskelee Farm will review important farm safety rules once all guests have arrived. Some rules reviewed will include; (**you can share this information ahead of time with the parents**).
    - No running, screaming, or chasing the animals (this will scare the animals).
    - Guests must stay with the tour guide and the group at all times. Adults need to accompany the children the entire time.
- (:00ish) Back to the barn for celebrations, food, piñata, craft, presents etc. Client to provide all.
  - Crafts or piñatas are a good way to keep kids entertained in the barn. Guests are not allowed to wander the farm unattended and must stay in the barn or tent area during your celebration time.
- (:00) Guest's leave and client cleans up the barn and returns it the way they found it. If you choose decorations from us please leave them up so we can reuse them. Damaged decorations (table toppers, backdrop, banners) will result in a \$50 fee.
- (:15) Out by the 15. Please leave on time as we have other parties coming in. If the space is not cleaned and we must clean up for you a \$100 cleaning fee will be charged.
