- Absolutely NO hand feeding horses.
- All forms of entertainment must be approved by Triskelee Farm LLC before the time of the event.
- No outside alcohol or liquor on Triskelee Farm property.

As unforeseen events may occur, we cannot be held responsible for those (i.e. COVID-19, State mandated closures, theft, accidents, and incidents that are beyond a normal person's control and are in no way negligent towards said confirmation). If such an incident should arise, it is our priority to fulfill the obligatory duties set within the event contract.
