COMES NOW Petitioner, Kimberlee Wentz (n.k.a. Kimberlee Singler), and does hereby submit Petitioner's Motion to Compel Court to Continue Status Conference Scheduled for Today, December 20th, 2023 at 1:30pm and Petitioner's Status Report Regarding Incident that Occurred on December 18th, 2023:

- On December 18th, 2023, at about 11am, someone broke into my residence and attacked the children and myself. Ellie and Aden were murdered, and and I were left to die, but we survived. I was just released from the hospital yesterday, and is still in the hospital. Given the circumstances, is in temporary custody of El Paso County DHS.
- I had no ability to call 911 until approx. midnight on December 19th, 2023, so obviously, I had no idea that Respondent's counsel had called me or sent me any emails. I only just learned of this Status Conference, which is scheduled for today, December 20th, late last night.
- 3.) My residence is currently locked down, during the investigation, so I have no access to any of my personal belongings. I am on a public computer, in a public place, at the public library. I have no access to a private computer right now, which would allow me to attend the Status Conference virtually. I have no ability to attend in person either, as I do not have access to my driver's license, and therefore, cannot drive myself anywhere. Furthermore, I am unable to attend in person/virtually/or otherwise, because I have lacerations on my neck and wrists, and although I have been released from the hospital, I am weak, in a great deal of pain, and I will require further medical treatment/check-ups/etc, for at least the next ten days.
- 4.) I do not have access to my phone or to my laptop, as all electronics inside the residence will be kept for an undisclosed amount of time, by CSPD, as evidence during the investigation. I have tried logging into my email from a public computer, but it requires that I receive a security code to my cell phone (which I have no access to right now), so I am trying to figure out a way to gain access to my emails.
