An example of the logistics of such permission may be as follows:

Senior student engages fully in the morning sessions of our academic program, followed by morning dance classes. At 1:30 PM, this student travels off campus to a nearby coffee shop to enjoy lunch and to engage in her college coursework for dual enrollment. The students' college coursework takes place in an online environment through our partner school, a community college. The student provides evidence of progress to the academic instructor and/or director prior to returning to Cary Ballet Conservatory for afternoon dance class. The student has utilized the opportunity to travel off-campus for a portion of her school day through responsible self-regulation of her independent classwork and by providing such evidence for verification and continued permission for off-campus travel by the instructor. A student who does not maintain self-regulated behavior is at risk for revocation of this permission by the academy faculty, staff, or director.
