ARTICLE 10 – CANCELLATION

In the event that the performance is rendered impossible by any act of nature, illness, war or other causes beyond the control of the parties, artist's expenses will in any case be covered by the "BUYER". Both parties will do their best to reschedule the concert within TWO MONTHS of the original date. In the event that the "BUYER" will decide to cancel the concert after signature of the contract, the "BUYER" will anyhow pay the entire fee to the artist.
