LACK OF SOCIAL, RACIAL, ECONOMIC, AND LEGAL JUSTICE HAVE PLACED AMERICA IN A DANGEROUS SPOTLIGHT

The Bureau of Justice Statistics (BJS) reported that we have approximately 2.9 million people incarcerated in penitentiaries or prisons out of which nearly 200,000 are serving life-term sentences. We, today, see the acceleration in these statistics with the arrest and convictions of murderers, rapists, child molesters, pedophiles, and the slaughtering of men, women, and children in grotesque and/or non-descriptive manners.

The Federal Bureau of Investigation (FBI) says that many of these mal-adjusted criminals are verbally, socially, and mentally challenged. They lack ability to reason and communicate which could decrease tension, calm emotions, and avoid senseless murders.

Thomas J. Gallagher, a 36-year agent (now retired) was asked by me to explain the continued increases in rapes and murders in America. His remarks were horrific. He said, "If you look into the etiology of families, there are signs of potential maladjustments in parents and/or their siblings. Most--not all--were reared by uneducated, low-income, and disaffected people who have no respect for law and order, not necessarily parents, with limited verbal skills. Poorly reared children grow up to emulate their parents and peers, teachers, or most influential people in their living and social environment such as gangsters, robbers, pimps, prostitutes, drug-dealers, rapists, pedophiles, up to and including prominent, socially well-connected and wealthy murderers, con men, rapists, and unknown law violators.

This country is on a downward spiral, and if we continue on this current path a new "civil war" will be our destination. Some states already passed laws allowing its citizens to place bounties on other citizens just because they choose to make a medical decision that others don't agree with. All of a sudden people are so pro-life, and believe in protecting all life, yet, they still allow for people to be executed.

Our politicians are acting like elected "gangbangers" fighting to support their members and their colors (whether red or blue). Sadly, it doesn't even matter if their members are in the right or morally wrong. Their behaviors are no different than some of the "street gangs" we call criminals that battle over their colors (red or blue) and their members. "Street gangs" kill, rob, and destroy communities with direct violence and intimidation. Our "political gangs" (Democrats and Republicans) kill, rob, and destroy communities through intimidating press conferences, policies, and legislation or the lack thereof.

(Lack of Social, from p. 1) ... time reveal from family dynamics no reading material no constructive endeavors, group dysfunctionality, and extreme poverty. Poverty strikes at the core of a person's life or livelihood. It places pressure on families and individuals to change their circumstances by getting an education, learn new skills, or resort to crime to 'take up the slack.' They call this 'breaking the cycle of poverty.'"

On further questing about wealthy criminals and why they commit crimes, Gallagher remarked, "On the other hand, we have hard-core criminals from wealthy and well-to-do families who have everything they could ever want or need, such as money, cars, good homes, clothes, luxury lifestyles, and good friends. But there was something missing in their lives--depending on age, it could be love, attention, family togetherness, idleness, lack of excitement, and not interacting with families due to professional and lay responsibilities, among other things."

"In order to get attention, they resort to criminal activities, starting with low-level crimes and advance to child molestation, rape, drug use, and murder. Due to social status, they most often get a lighter sentence. Social elites who commit crime try to shield themselves behind their status. Look at Harvey Weinstein, Bill Cosby, Kwame Kilpatrick, and the several Detroit City Councilmen and Councilwomen."

Finally, Gallagher concluded, "Oddly, some wealthy and non-wealthy people, mostly males, drop out of school or college to pursue a life of crime. We have not quiet understood why."

"Some of those with severe mental and emotional problems, undetected by parents, siblings, or friends, are unable to rationalize their conduct and behavior, resort to 'thrill killings' to achieve mental and emotional gratification and attention. Until identified and apprehended, they will continue on this path up to and including murder."

WOMEN'S HURON VALLEY CORRECTIONAL FACILITY

Mission Statement

1. Our goal is to put a 25 year cap on life without possibility of parole (LWOP) and life with parole sentences and reverse the five-year review policy, reviewing life sentences every two years. The current five-year review policy only extends the period of incarceration.
2. Grant opportunities for those serving long-indeterminate sentences to see the Parole Board in 10 years or at half of their minimum sentence.
3. Give sentencing judges judicial discretion to render appropriate sentences by taking into consideration the circumstances surrounding the offense and the offender's involvement and culpability.
4. Make available programs for lifers to help them rehabilitate.

Some Facts

1. The United States represents 5 percent of the world's population but 25 percent of the world's prison population.
2. Life-long sentences do not lower crime rates. ... (Cont. on p. 4)

3. As several research studies have shown, even after serving 25 years, people can be successfully reformed or rehabilitated and become productive members of society.

Consider

Among women serving life sentences are:

1. Battered women;
2. First-time offenders; and
3. Women who were not responsible for perpetrating the offense who, knowingly and unknowingly, aided and abetted in the commission of the offense.

Solutions

1. Give discretion back to judges and the Parole Board by eliminating legislative sentencing mandates and mandatory life without parole sentences.
2. Focus on rehabilitating offenders because no life is irredeemable or beyond change.
3. Cap first-degree homicide to a maximum of 25 years.
4. Reinstate wardens' ability to recommend up to 5 commutations per year to the governor for lifers and those serving long-indeterminate sentences.

CHAPTER 1014
LEGISLATIVE COMMITTEE
WOMEN'S HURON VALLEY CORRECTIONAL FACILITY

WE PROPOSE:

1. Revise MCL § 750.316 First Degree Murder to allow convicted persons under this statute to be parole eligible after 25 years unless documented evidence is presented that supports the person is a risk to public safety as any other parole eligible person. Remove the mandatory life without the possibility of parole sentence giving judges the opportunity to sentence according to circumstances of the crime and culpability of the offender.
2. Revise MCL § 750.317 Second Degree Murder to allow convicted persons under this statute to have a presumptive parole after 20 years unless documented evidence is presented that supports the person is a risk to public safety as any other parole eligible person. Stop the life means life mentality of the Parole Board.
3. Enact Second Look Sentencing legislation to include 1 and 2 above.
4. Implement an independent Lifer Review Board who will review life without possibility of parole cases and life with parole cases to recommend to the Governor those prisoners who are rehabilitated and no longer a threat to society for a Public Hearing and Commutation.
5. Revise statutory requirements for Public Hearings for life with parole prisoners placing sole decision making for parole release with the Parole Board.
6. Place the Lifers Review Board and the Parole Board under the Civil Service Commission rescinding autonomy of the Parole Board providing some oversight.
7. Require the Parole Board to give all lifers a reason why a "No Interest" decision was given and what a lifer needs to do to improve their chances for a parole.
8. Create a Lifer Review Board of Appeals where lifers can appeal parole and commutation application denials.
9. Revise the 5-year Lifer File Review period, reducing it to every 2 years. The 5-year period has no penological interest except to prolong incarceration.
10. Amend the Aiding and Abetting statute adding a maximum 15-year sentence for anyone convicted of aiding and abetting a first degree murder under MCL § 750.316.
11. Allow wardens at correctional facilities to recommend for commutation of sentence to the governor 5 lifers per year.
12. Allow long-indeterminate sentenced prisoners to be seen by the Parole Board either after they serve 10 years or once they serve half their sentence. The 10-year mark would coincide with File Reviews of LWOP prisoners.

PRISONS: A MICROCOSMIC SOCIETY BEING SECRETLY PREPARED FOR MIND CONTROL TO HELP ERADICATE CRIMINAL THINKING

The occurrences in our prisoner are reflective of the larger society. This means that prisons are microcosms of the macrocosmic society. Prisoners learn antisocial, criminal mindset and behavior in society from which it is transposed and transferred into a smaller controlled society--prisons.

Many sociologists believe our children are negatively influenced by/from the dictates of the environment in which they were born, reared, and reached adulthood. Also, the media, TV, movies, certain toys (guns, knives, etc.) and how they interact with these exposures as children and as adults. This could be translated to mean we are the by-products of the environment in which we were born, raised, educated, socialized, and introduced to the world outside of our environment.

Also, criminologists, social scientists, psychologists, psychiatrists, school teachers, and the medical community have been trying to find the "root cause" of criminal behavior--when it began, where it began, how it began, why it began, and how to stop it because crime is rapidly increasing at alarming rates.

We can no longer attribute such crime as caused by dysfunctional families, disorganized neighborhoods, poverty, drugs, alcohol, or mental illness. The crime rates in affluent communities are rising. Doctors, lawyers, judges, mayors, law-enforcement officers, and prosecutors have turned to be criminals. Why?

In earlier years, some psychologists and criminologists believed the shape and size of one's head were factors to consider; others thought the physical build, size of one's eyes, lips, and facial features were contributing factors to antisocial behavior.

Still, a few believe that some people are

born with defective genes that could render them criminally predisposed, and if they could detect and remove this gene while the child is still in the fetus stage in the prenatal environment, the fetus could grow through the rest of the parental stages of development, birthed, and grow to be a normal person.

Today, theorists have concocted many theories and have tried them on both civilians and prisoners--without their knowledge--to test their effectiveness on crime prevention.

Psychologists, psychiatrists, and criminologists say that during their disciplines and practices, prisoners have confessed to them crimes they committed and never caught and not knowing why they committed crimes even though they have all the comforts, necessities, and privileges a person can hope for.

Perhaps, one day, some of these theories, if proven true, may reduce or eliminate criminal behavior and help rebuild a safe society. Remember and don't forget: theories are just that--theories--until or unless they have undergone experiment after experiment (testing) and the results are always the same. Once proven true, they begin to gather clients or willing participants to apply what they had learned.

There was another psychiatrist working with a criminologist and theorist who believed that we need to develop a brain chip that could be inserted into one's brain, controlled externally by computers to study and analyze one's mind and thinking patterns; the person could be deterred from criminal behavior.

As in the macrocosm (society), those in the microcosm (prisons) may be subjected to a lot of dangerous methods of mind control that are secretly being discussed in the scientific community. The public and prisoners will ... (Cont. on p. 7)

Trying to buy a gun legally never crossed my mind. No criminal or street thug things about buying a legal gun. I know, I was one of them. I couldn't legally buy a gun anyway because I was only 16, but my surroundings, upbringings, and culture made me feel the need to have a gun. The fact of the matter is money, people, circumstances, and gun manufacturers provide access to guns, and this access at times can end in violence.

I'm not against gun laws, I just don't know what laws can be passed that will stop someone from getting a gun, especially when there are millions of guns in this country, with many more being produced and smuggled into the country each year.

No gun law back in the 90s when I was 16 years old, nor any gun law of today, would have prevented me from getting that SKS assault rifle. And I did buy that SKS assault rifle for protection or self-defense. I could have easily kept the smaller pistol I had or bought a larger caliber hand gun for protection. My stupid reason for buying the SKS assault rifle (very similar in power to an AR-15) was to boost my self-esteem and gain recognition from my peers if and when I had to use it. Thank God I never participated in a mass shooting with it.

To criminal, and those on the verge of becoming a criminal, assault rifles are used specifically to kill and destroy whatever and whoever is the target. Plus it's a menacing and intimidating weapon that gives the criminal the tactical advantage over other criminal and police alike because a police officer's bullet proof vest is useless when it comes to an assault rifle as the SKS or AR-15. No one on the receiving end of an assault rifle's bullet can take cover because the bullets can penetrate just about anything.

That is what makes assault rifles so enticing to a person wishing to cause carnage. Remember, I was just 16 years old when I purchased my first assault rifle, and guns back then (1992) were a lot harder to get legally and illegally in Michigan. I'm saying all this to say that even if we have stricter laws and never had a Second Amendment right, as long as guns are allowed to be manufactured in this country and you have money, people will get their

hands on a gun, good or bad, law abiding or criminal.

I just don't understand how this nation in which many would claim to be built on "Christian" principles can allow for little children and teachers to have their God given rights (the right to life and to live) taken away, but are willing to fight like hell to protect Man-made rights (Second Amendment right to bear arms) that was given by the Found Fathers.

We are at a crossroad America, the rights from God or the rights from Man. Which one will you defend?

Even lay and professional correctional staff will not be informed. Providing such information is on a need-to-know basis. When they believe their methods, pills, brain chips, and behavior control devices are perfected for us, who will be the experimental guinea pigs? They will be the unsuspecting members of society who exhibits predispositions to criminal behavior or the chronically recidivistic prisoners.

Think about what's on the horizon for behavior control! Did George Orwell see this coming? Didn't he have it in his book "1984"?

Orwell once said that there will be a time when we have "thought police" who will be trained on how to read your mind, intercept your thoughts, and if you are thinking about committing a crime, you will be arrested and charge with a felony against the citizens of the United States.

You don't have to commit a crime, just think about committing it. What are they planning to do next--arrest your brain and charge it with criminally malfunctioning?

NOW WHAT? IGNORE THE SCIENCE AND
IMPLICITLY REINSTATE AND
IMPOSE THE DEATH PENALTY?

Although I'm sentenced to death-by-incarceration (i.e. life without the possibility of parole), I don't want to die in a prison cell by asphyxiation because I became reinfected with COVID-19. The State of Michigan abolished the death penalty decades ago. Should I be resentenced to a torturous death because our political leaders maintain a retributive attitude of yesterday? If Michigan's political leaders ignore the science, they are implicitly reinstating and imposing the death penalty on incarcerated Michiganders.

Michigan's Governor consistently states all her decisions concerning COVID-19 and the safety of Michiganders are based on "the science." The science determined COVID-19 antibodies start to dissipate from the body after two weeks and can remain for up to three months, providing only short term protection from reinfection. Then we can't disregard any mutated form of COVID-19 that sweeps across Michigan.

COVID-19 vaccines are proven to only protect some individuals from severe infection and hospitalization. Vaccines do not protect from becoming infected.

Now what? Is Michigan's Governor going to ignore "the science" of reinfection, implicitly reinstating and imposing the death penalty on incarcerated Michiganders? Or is she going to truly follow "the science" and protect all Michiganders, including the incarcerated, by exercising her Executive Authority, under the State of Emergency, releasing thousands of incarcerated Michiganders in order to prevent further death? Reducing the prison population and single bunking and closing all open-setting housing unit facilities.

"How can she do that?", you may ask, "I've heard her say Truth In Sentencing prohibits her from taking such action." The Governor has Executive Authority under Michigan's Constitution to commute any sentence. She can commute thousands of sentences with a stroke of a pen, bypassing

Truth In Sentencing.

This is an opportunity for the Governor to reduce the mass incarceration that has plagued the State of Michigan since the 1980s. The death penalty should not be implicitly reinstated and imposed on anyone through the failure to follow "the science" or through the failure to take action to protect incarcerated Michiganders because our Governor and Legislature refuse to let go of the lock-em-up-and-throw-away-the-key mentality.

RESPONSE FROM MICHIGAN DEPARTMENT OF

ABOUT PROGRAMMING

Many lifers and virtual lifers have written and asked me why are short-termers targeted for academic, vocational, and therapeutic programming while long-termers are systematically overlooked and denied the same opportunity.

I have repeatedly explained to all MDOC prisoners that the current focus is to concentrate on prisoners, male and female, who will be interviewed by the Parole Board within 3 to 5 years.

I decided to contact the Education Section of the MDOC for more information about educational policies and programs. I received a letter dated July 13, 2022, stating the following:

ATTN: Willis X. Harris

Thank you for your interest in programming that the Michigan Department of Corrections (MDOC) offers, and our partnerships with colleges throughout Michigan. As you may have heard the U.S. Department of Education has admitted several Michigan colleges and universities to offer college programs within MDOC facilities, with the MDOC's support. Interested students must have funding to attend these programs, and one avenue for funding is by completing the FAFSA forms to see if the potential student(s) are Pell Grant eligible. The MDOC does not have influence over Pell Grant eligibility.

(Response From MDOC, from p. 8) ... with Calvin University and Hope Western Prison Education Program (Hope College and Western Theological Seminary Partnership), and they do offer college programs to students that are serving long sentences and life. Both programs can lead to a 4-year bachelor's degree, and a chance for graduates to have a positive impact in their community, whether that community is inside or outside of a correctional facility. NOTICE TO READERS

On August 25, 2022, the Macomb Correctional Facility experienced another wave of COVID-19 infections with 49 prisoners testing positive in Units 3 and 5. This is the second wave of infections for 2022. The Macomb facility was last hit in January.

On Friday, August 12, 2022, on page 3A of the Lansing State Journal, Paul Egan reported in his article titled "Mich. prisons called ticking 'time bombs'", that Byron Osborn, president of the Michigan Corrections Organization, was extremely concerned that the shortage of prison guards will lead to a dangerous situation if not addressed. He said he was seriously considering asking Governor Gretchen Whitmer "to activate the Michigan National Guard -- which has helped with prison vaccinations during the COVID-19 pandemic -- to ensure Michigan's 27 prisons have adequate security and give close to 6,000 corrections officers some badly needed rest." While Osborn does indicate a concern with lack of programs and outdoor exercise for prisoners, he fails to mention reducing the prison population.
