In the event I show signs of distress or call for aid, I would like assistance and will not hold Lazy Lizard Tours LLC, their crew or passengers responsible for their actions in attempting the performance or rescue of first aid.

I agree to forever discharge and release <u>Lazy Lizard Tours LLC</u>, its employees and agents, the owner(s) of <u>Lazy Lizard Tours LLC</u>, and affiliates, from any and all responsibility or liability for any and all injuries or damages. I agree NOT to make a claim against or sue any of the above parties for injuries or damages whether they arise or result from any NEGLIGENCE or other liability, EVEN IN CASES OF GROSS NEGLIGENCE. I further specifically agree, on behalf of myself, my heirs and assigns, to indemnify and hold harmless the released parties for any and all causes of action arising as a consequence of any incidents which might occur as a consequence of my participation in any activities with or involving the released parties. I understand that if I leave the boat for any reason and enter the water, I am fully responsible and hold harmless Lazy Lizard Tours LLC. I agree that *Lazy Lizard Tours LLC* may take and use photographs of me with or without my name and for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and Web content.
