Sarcoma Awareness Month

Sarcoma is a rare type of cancer that originates in the connective tissues of the body, such as muscles, bones, fat, blood vessels, tendons, and nerves. Unlike more common forms of cancer, which begin in organs, sarcomas can develop in any part of the body. This diversity makes them particularly challenging to diagnose and treat. Sarcoma are a complex type of cancer that can trick the body into thinking the tumor is merely normal tissue. They develop in connective tissue, bone, fat, and muscle. Sarcomas occur much more prevalently in children (about 15% of cancer cases) compared to adults (1%) in the U.S.

The most common form of sarcoma in the U.S. is gastrointestinal stromal tumor (GIST), which affects approximately 4,000 to 6,000 people annually. Per the Fred Hutch Cancer Center, sarcoma can be diagnosed by.

- Imaging tests such as an MRI, CT scans, and PET scans to visually detect sarcoma.
- A biopsy whereby a medical practitioner extracts tissue to confirm the results of an imaging test.

Symptoms and Early Detection

Early detection of sarcoma can significantly improve treatment outcomes. However, the symptoms often vary depending on the sarcoma's location. Common symptoms include:

- A noticeable lump or swelling that may or may not be painful
- Persistent pain, which can be severe and worsen over time
- · Fatigue and unexplained weight loss
- · Limited range of motion if the sarcoma is near a joint
