Stock - Request for Bid

RODEO DETAILS:

The Gallup Inter-Tribal Indian Ceremonial Association (GITICA) is soliciting bids for stock for the following Open Show Rodeo. Dates and times of performances and slacks are subject to change:

- Wednesday, August 5, 2026 – 7:00pm Iron Cowgirl
- Thursday, August 6, 2026 – 9:00am Timed Event Slack
- Thursday, August 6, 2026 – 7:30pm Rough Stock Slack
- Friday, August 7, 2026 – 1:30pm Performance
- Saturday, August 8, 2026 – 1:30pm Performance
- Sunday, August 9, 2026 – 11:30am Performance (Short Round/Old School)

The Rodeo will be held in Red Rock Park, Church Rock, New Mexico.

BID TERMS AND CONDITIONS:

- Stock Contractor (SC) shall provide sufficient stock with prior rodeo experience.
 - Preliminary stock numbers will be available on Wednesday, July 29, 2026, at 6:00pm.
 - The Horse and Bull Stock Contractor shall provide a bid for the required stock, bucking chute help, loading/back pen help, and draw for all stock.
 - Bull Stock Contractor shall ensure the bulls included in the bid score more than 18 points and no more than 22 points.
 - SC shall provide 2 bull fighters and 3 pickup men as part of the bid.
- Stock Contractor (SC) shall provide a bid for the required stock, roping chute help, roping stripping chute help, and draw for all stock.
 - SC shall ensure the bulldogging and team roping steers are even in weight, horn length, and size.
 - SC shall ensure the calf roping calves are smaller than the breakaway roping calves, even in weight and size, and under 250 lbs.
 - SC shall ensure all calves used in the breakaway roping events have horn lengths of less than 2 inches and are even in weight and size.
 - SC must provide separate drawing pools for TDR and LBAW. Stock will be sorted into the draw pool and brought down to the roping box.
 - SC must provide separate roping steer pool for Night Roping on Thursday to Saturday, if hosting.
- Stock Contractor shall provide its own trucking to and from the event.
- Stock Contractor shall furnish all equipment, tools, labor, and other items necessary to fully perform the agreement.
- Stock Contractor shall use its best efforts to care for and preserve all equipment provided for use during the event.
- Stock Contractor shall be on site 3 hours prior to each scheduled event and be fully prepared to perform services.
- Stock Contractor and its helpers shall comply with local GITICA ground rules and the event schedule as set forth.
- Stock Contractor and its helpers shall not use or possess any intoxicating alcoholic beverage or illegal drugs on or around the rodeo grounds.
- Stock Contractor shall provide production coordination and cooperation with GITICA.
- Stock Contractor shall provide its own liability, auto insurance, and workers' compensation coverage at no cost to GITICA.
- Stock Contractor, its helpers, volunteers, laborers, and anyone else associated and/or affiliated with the

contractor shall indemnify and hold GITICA, its board, committee, officers, sponsors, officials, employees, and volunteers harmless from any and all claims, injuries, damages, losses, or suits, including attorney fees, arising out of or in connection with the performance of this Agreement.

- GITICA may, at its discretion, provide an additional amount for livestock feed for the event.
- GITICA will not provide lodging for Stock Contractor(s) at this event.
- GITICA will have parking/hookup spaces available for Stock Contractors' use. The deadline for requesting a space is Thursday, July 30, 2026.
- GITICA will provide a set number of access passes for the Stock Contractor and named sub-stock contractors. Any additional passes requested will be at the contractors' expense.
- GITICA may terminate this Agreement immediately, upon written notice, if Stock Contractor fails to comply with the terms of this Agreement.
- In the event of any breach of this Agreement, GITICA reserves the right to adjust or reduce the amount due to satisfy the breach.

SELECTION: Winning bidder(s) will be notified by 5:00 p.m. MST on Tuesday, April 14, 2026, and will be required to sign a fixed-price service agreement within 3 business days after notification. Failure to sign the agreement will result in the award being offered to the next best bid. Once the agreement has been fully completed, the full amount will be paid at the conclusion of the rodeo. Winning bidder(s) shall provide a signed W-9 and invoice to the committee upon award.

I understand that arena conditions may change from time to time and may increase or decrease the risk of injury to me, my personnel, or my animals. I have evaluated these risks and voluntarily agree to assume all risks and liability.

I hereby forever release the Gallup Inter-Tribal Ceremonial Association, GITICA Rodeo Committee, the City of Gallup, Red Rock Park, its board of directors, any affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives ("Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse, and legal representatives now have or may have in the future for any injury, death, or property damage related to the following:

1. My participation and the participation of my animals in this event; or
2. The negligence or other acts, whether directly connected to this Rodeo or not, and however caused by any Releasee; or
3. The condition of the premises where these activities occur.

I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse, and legal representatives will not make any claim against, sue, or attach any property of any Releasee in connection with any of the matters covered by this release.
