Business Arising from Minutes

Jackie Lynch: Valentine's Bonspiel: Cancelled. Sean Ford has made refunds to teams. Still waiting on vendors to be cancelled. OCA loan and membership payment:

The Club has one remaining \$6,000 loan payment to the OCA/CurlOn along with the membership fees for the 2021-22 season.

Jeff Glover advised we pay the fees on the loan, but to hold off on repaying the loan. Board unanimously agrees to pay fees.

<u>Calcutta</u>

The board briefly discussed hosting a Calcutta at the end of the year. Must gauge interest from club members before proceeding.

Manager's Report

Club Manager, Sean Ford, provided the following updates:

17 squares remaining in Super Bowl pool.

Brackets on post in ice shed to be put up on Friday the 11th.

POS system has been up and running for over a week. POS system is very easy to use and very beneficial to club operations and accounting. Also helpful for reports and intelligence for sales purposes.

Lots of requests coming in for rentals. Sean is going to open a calendar for availability to board members to view.

Most administrative/operations forms and files have been lost, Sean stated they must be rebuilt and held onto to develop continuity for the future.

Sean made a request to the board to allocate money to cover workplace training / safety training courses for employees. Roughly \$400. Jeff Glover motions to approve request, Spencer Maves seconds motion. Motion carried.

NFCC is now partnered with backcheck.com, Sean recommends we motion to pay for background checks for volunteers. June Lumber makes a motion, seconded by Randy Elliott.

Looking ahead, Sean brought up the following:

- Need to do Puck Board on edges of rink, cost of roughly \$1000
- 3 fans in ice-house need to be replaced (these save us money)
- Suggestion by Sean to buy an install a second temperature probe into ice at a cost of roughly \$300
- Request to potentially rent a one person genie lift at end of the season for maintenance
- Quote will be presented for cameras at far end at next month's meeting
- Sean will provide numbers on how much the new plant costs us and how much the plant is saving the club
- We will be getting rid of the VISA account, in progress
- Sean is looking for someone to take over the Thursday night league to take it off his plate

Committee Reports:

Finance Report: Jeff Glover provided an update as follows: Income: \$107,118 Expenses: \$110,000 Profit (Loss): (\$3000) We are currently running at 50% of our normal hydro bill. OCA loan still outstanding at (\$6000).

We pulled 7 names for debentures. We still owe \$74,000 on debentures in next 13 years.

Ladies section offered \$1,800 towards replacing carpets and fixing backboards.

Facilities: Tim Williams

The restart of the ice plant and the club has gone off without any major problems; a job well done by Sean. There are still some complaints regarding the runners on the end boards, the preliminary cost to replace them seems more expensive than anticipated. The reinforcement of the beams is ongoing. Dave and Doug are taking on this task. A new item of concern is some water penetration on the east wall. This may be a one-time issue due to the weather. We will keep an eye on this situation.

We continue to have a great deal of success in reaching the community through both updates on the website and through Facebook and twitter.
