New Business:

- The VC's have decided to have the County Committee to meet on Thursday, January 11th at 7:00 to fulfil The GOP Convention Call and distribute phone lists for each Precinct Captain to call 100 of their precinct Republicans to invite them to the Precinct Caucus and to our meetings. We will also try to get the emails so the Precinct captains can email important information to them .
- We are not encouraging Church Rental at this time. It is taking too much time to locate a church willing to pay decently. Last Church was 1200 for 5 or 5 weeks. 4-5 hours given in the middle of the day. Stressful for Calvin and me to have Saturday event and then go clean for Church early Sunday. I just got an event for Superbowl Sunday paying 850. We can make more money with separate events instead of a Church at this time. If money gets scarce we can reconsider.
- I have also increased the Security Deposit on the rental from 150 to 250. It seems as if there are security deposits of 350. You can't hardly buy or fix anything for 150.
- Maximum of Parties restricted to 80 people. Parties of 100 are too big if they are dancing and eating. Takes too much of a toll on our facilities.

- Because of the new limits on people our round tables are being utilized. I have had two of our round tables fixed but they are still not good. I believe our tables are 10 years old currently. I suggest getting rid of the two not great tables. At the present time we can buy 1-3 tables from lifetime for 499 each or 4-9 tables for 400 each. Taxes would be added. Walmart 72 inch Round table 259.
- We are having weekly Thursday Steering Meetings, this allows the VC's meet each week as their schedule permits, our new candidates come and get to know us, lets key R party members meet with all the members, lets new members get involved with the party. This weekly meeting of the VC's , Secretary, and Immediate Past Chairman have allowed us stay on course and responsive to the needs of our Party.
