## Waiver of Liability, Assumption of Risks and Release Agreement

\*Wherever mentioned in this or any other document, Island Cup and Westshore Spring & 4x4 Inc. and the property owner, Byron Connell, with which Island Cup and Westshore Spring & 4x4 Inc contracts or arranges for the use of land for events, such reference is intended to include all officers, directors, affiliates, committee members, volunteers, agents, servants, staff, employees and contractors of each entity. Throughout this and any other agreement, they are collectively and individually referred to as "Island Cup/WSS/Byron Connell".

Driving vehicles off-road, whether on work roads, trails or over rocks/boulders, is dangerous and contains hazards and risks that can result in damage, including injury, property damage and death ("damages" throughout). I am fully aware that participation in this activity, whether driving, riding as a passenger or observing, is hazardous and involves risk. I willingly and knowingly accept those risks, and I willingly and knowingly accept all legal responsibility for any personal injury, death or property damage which results from my participation in this event and my use of the facilities, equipment and property of Island Cup/WSS/Byron Connell.

2.2 I understand that there are rules that apply to all participants in the event, and that it is my responsibility to have a complete understanding of the event rules. The rules are included in the competitor welcome package.

RELEASE FROM LIABILITY: I release and hold harmless Island Cup/WSS/Byron Connell from any and all liability for any claim, loss, damages (as defined above), regardless of the cause, including negligence of Island Cup/WSS/Byron Connell, sustained by me or my property while participating in events covered by this Agreement. By entering into this Agreement, I understand that I am surrendering legal rights which I may otherwise have against Island Cup/WSS/Byron Connell.

COVENANT NOT TO SUE Island Cup/WSS/Byron Connell: I will not make any claim or bring any legal action or voluntarily assist in any legal action against Island Cup/WSS/Byron Connell, nor permit anyone else to do so on my behalf for any claim, loss, damages (as defined above) sustained by me or my property during events covered by this Agreement. It is my express intention to waive any and all claims which I have, or might have, or which anyone may have acting on my behalf, to bring any form of civil suit arising out of my participation in the event.

### 7. INDEMNIFICATION AGAINST OTHER CLAIMS: I agree to indemnify and hold

Island Cup/WSS/Byron Connell harmless from all claims and suits by anyone, including insurance carriers, for personal injuries, death or property damage arising out of my participation in this event and/or my use of the facilities and property of Island Cup/WSS/Byron Connell. I agree to pay to each indemnified party against whom such a claim is asserted all costs and legal fees expended to defend such claims as well as any sum of money paid to claimant by Island Cup/WSS/Byron Connell as a result of judgment or settlement. I recognize and understand this indemnification provision is distinct from and independent of the release provisions.
