SCDC Policies 2025-2026

1. \$30.00 non-refundable registration fee, and signed release and waiver must accompany registration form. Registration fees are good until the next registration date of the following year.
2. Tuition fees are non-refundable except in the case of class cancellation. The minimum number of students per class is five. If the class number drops below five, the class may be combined with another class or cancelled.
3. Students may not attend class unless all fees are current. **THIS WILL BE STRICTLY ENFORCED!** Monthly tuition is due the 10th of each month. September through June will be charged a full month's tuition. Whether we have a short month (3 weeks) or a long month (5 weeks), tuition remains the same. A \$15.00 late fee will be added after the 10th of each month.
4. There are no refunds for missed classes, fees, or any items purchased. Missed classes may be made up in an age-appropriate class and must be done within 4 weeks of the missed class. If we close due to weather, studio emergencies or illness of teacher, we will do our best to offer a rescheduled class on a different day within the next few weeks. It will be posted IN STUDIO as well as on our FB page.
5. All classes are closed session. Do not open the door during class time. When classes are over, the instructor will open the door. Parents and siblings inside the classroom are too much of a distraction to the students.
6. All tuition and payments must be current before purchasing costumes and recital tickets.

***due to issues with non-payment SCDC requires the name, phone number and address of person responsible for monthly tuition payments.

7. SCDC follows the local school holiday schedule and snow closings. These will be posted in the studio.

8. Dance attire and hair:

***Ballet, Tap and combo Tap/Ballet Classes: leotards and pink ballet shoes are required for all ballet classes. Hair should be pulled up in a bun or neatly off the face. Black tap shoes are required for tap.**

***Jazz and Tumble classes must wear dance attire that fits tightly. Unitards or leotards are strongly suggested. No loose fitting shorts or shirts. Hair must be pulled back and secured off face. BEIGE jazz shoes. No shoes are required for tumbling.**

***Tiny Toes Pre-Dance classes should wear dance attire and appropriate shoes with hair pulled back secured off face. Pink Daisy Capezio Ballet shoes are preferred.**

9. No gum, food, or drinks allowed in the studio where students are dancing. Students may take a water bottle into class. NO JUICE OR SUGARY DRINKS as these can ruin our floor.

10. Studio C does NOT tolerate bullying in or outside of our studio. Any such behavior will result in dismissal from the studio. This includes parents and siblings. We strive to be a friendly, safe environment for everyone.
