KCNL By-Laws, Article 1, Section 4. Vacancies.

Vacancies on the Board of Directors shall be filled by a vote of the remaining Directors then serving. A vacancy shall occur upon the death, resignation, or failure of a Director to attend three (3) consecutive meetings of Directors whether annual, special or regular; provided however, for good cause shown, the remaining Directors may by resolution duly adopted, excuse the third (and subsequent) consecutive non-attendance(s), re-elect or reinstate a Director whose position had become vacant from non-attendance. Any Director may be removed from office by a vote of two thirds (2/3rds) of all other Directors then serving. A vacancy in any office, because of death, resignation, removal, disqualification, or otherwise, may be filled by the Board of Directors then serving for the un-expired portion of the term of the departed Board member.

A motion to amend the KCNL By-Laws by paragraph substitution as presented below.

KCNL By-Laws, Article 1, Section 4. Vacancies.

Vacancies on the Board of Directors shall be filled by a vote of the remaining Directors then serving. A vacancy shall occur upon the death or resignation of a Director. A vacancy may also occur, by resolution of the Directors, if a Director fails to attend three (3) consecutive unexcused_meetings of Directors whether annual, special or regular. Directors may re-elect or reinstate a Director whose position had become vacant from non-attendance. Any Director may be removed from office by a vote of two thirds (2/3rds) of all other Directors then serving. A vacancy in any office, because of death, resignation, removal, disqualification, or otherwise, may be filled by the Board of Directors then serving for the un-expired portion of the term of the departed Board member.
