Stephen Maxwell provided the current policy renewal material to council members and reviewed the various changes. Travelers Liability Insurance Policy renewal. Mr. Maxwell reviewed the liability policy, discussing the increase in commercial property coverage by 6,650.00, the general liability policy increased 986.00, law enforcement increased 1,667.00, and the commercial auto increased 11,049.00, the total premium being 248,972.00. Alderman Friday asked if there are any other quotes. Mr. Maxwell explained that there are no other companies in Louisiana that offer municipal liability insurance. Mayor Horton stated what a great job Mr. Maxwell does for the town and that they are grateful for his service.

ORDICNANCE 590 of 2024 Water Rates

AN ORDINANCE TO AMEND ORDINANCE 504 OF 2013 AMENDING THE RATE SCHEDULE TO BE CHARGED FOR WATER SERVICE PROVIDED BY THE BENTON WATER SYSTEM TO CONSUMERS INSIDE AND OUTSIDE THE CORPORAL LIMITS OF THE TOWN

**BE IT ORDAINED BY** the board of aldermen of the Town of Benton, Bossier Parish, Louisiana, in regular session convened, that Ordinance 504 of 2013 be hereby amended by amending the rate schedule to be charged for water service provided by the Benton Water System to consumers inside and outside the corporal limits of the Town of Benton,

**WHEREAS** the rate schedule for residential water service inside the corporal limits of Benton shall be a flat fee of eight dollars and seventy-five cents (\$8.75), and six dollars and eighty-nine cents (\$6.89) for every 1000 gallons of water used, and

WHEREAS the rate schedule for compound meters and commercial water service inside the corporal limits of Benton shall be a flat fee of nine dollars and zero cents (\$9.00), and six dollars and eighty-nine cents (\$6.89) for every 1000 gallons of water used, and

**WHEREAS** the rate schedule for residential water service outside the corporal limits of Benton shall be a flat rate of fourteen dollars and fifty cents (\$14.50), and seven dollars and sixty cents (\$7.60) for every 1000 gallons of water used, and

**WHEREAS** the rate schedule for compound meters and commercial water service outside the corporal limits of Benton shall be a flat rate of fourteen dollars and seventy-five cents (\$14.75), and seven dollars and sixty cents (\$7.60) for every 1000 gallons of water used, and

**BE IT FURTHER ORDAINED** this Ordinance having been read in full in legal session, and considered section by section, was adopted on the 13<sup>th</sup> day of May 2024.

A motion by Alderman Jones seconded by Alderman Friday to introduce and set for Public Hearing on May 13, 2024. Mayor Horton called for any comments, there being none the following votes recorded:

#### **RESOLUTION 6 OF 2024**

A RESOLUTION TO AUTHORIZE PURCHASE OF WATER METERS AND AUTHORIZE THE MAYOR TO ENTER INTO A COOPERATIVE PURCHASING AGREEMENT WITH THE CITY OF MINDEN

WHEREAS the Town of Benton utilizes a single brand of water meters throughout the Benton water system to keep costs low and efficiencies high; and

WHEREAS the Town of Benton is continually replacing and upgrading old meters to maintain accuracy; and

WHEREAS the FY 2024 budget included funding for the purchase of meters as well as other related equipment; and

WHEREAS, due to supply chain issues the annual order has been on hold until June 2024; and WHEREAS, with the assistance of Underground Utility Supply the Town of Benton was able to locate sixty-four new meters in the City of Minden; and

NOW THEREFORE, BE IT RESOLVED That the Board of Alderman of the Town of Benton, Louisiana does hereby authorize the purchase 37 – ¾ inch meters and 27- 1-inch meters from the City of Minden for \$11,168.78.

BE IT FURTHER RESOLVED that the mayor is hereby authorized to sign all documents relating to the purchase of said meters. The foregoing resolution was presented by Alderman Jones and seconded by Alderman Manning for approval by the following vote.
