ORDINANCE 598 of 2025

AN ORDINANCE AMENDING ARTICLE I, "ADMINISTRATION" OF THE CODE OF ORDINANCES, TOWN OF BENTON, LOUISIANA, BY ADDING SECTION 2.8 WHICH SHALL READ "REGULAR MEETINGS OF THE BOARD OF ALDERMEN"

WHEREAS the Board of Aldermen of the Town of Benton desires to amend Article I by adding Section 2-8 of the Benton Municipal Code; and

WHEREAS, the Board of Aldermen has approved a change to the time of the regular monthly meeting, which is held on the second Monday of each month, the meeting time will be 6:30 PM.

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen of the Town of Benton, Bossier Parish, Louisiana, that the Municipal Code of Benton, Article I, ADMINISTRATION, be amended as follows:

Section 2.8, REGULAR MEETINGS OF THE BOARD OF ALDERMEN:

The Board of Aldermen shall meet regularly in the Municipal Building located at 105 Sibley Street, Benton, on the second Monday of each month at 6:30 PM prevailing time. When any regular meetings of the Board of Alderman fall on a holiday, the meeting shall be held at the same hour on the next succeeding workday, which is not a holiday.

BE FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent or in opposition to the provisions of this ordinance are hereby repealed in their entirety. This ordinance shall take effect after final passage and publication as required by law.
