1. ORDINANCE 592 OF 2024 AN ORDINANCE TO AMEND THE CODE BY AMENDING CHAPTER 2. ADMINISTRATION, ARTICLE 3. LAW ENFORCEMENT ADDING SECTION (A) AUTHORITY OF THE CHIEF OF POLICE

BE IT ORDAINED by the Board of Aldermen of the Town of Benton, Bossier Parish, Louisiana in legal session convened, does hereby authorize the elected chief of police, of the Town of Benton to appoint, promote, discipline, and dismiss police personnel subject to the budgetary limitations, pertaining to the number of allotted positions of the police department.

BE IT FURTHER ORDAINED that the chief of police shall be authorized to take whatever steps are necessary to effect disciplinary action concerning police personnel, including but not limited to the suspension of police personnel. Any such disciplinary action shall be taken without regard to race, creed, or color. This provision shall not, however, prohibit a police department employee from making a direct appeal to the board of aldermen, who shall have the authority to modify or reverse any actions of the chief of police.

#### **PUBLIC COMMENTS**

Alderman Cathcart stated that in the last meeting, he opposed this action but has now reconsidered. He supports this; however, he has a question about the last statement, which states that the entire ordinance gives the Chief authority to deal with his employees but, in the end, gives it back to the council if the employee wishes to appeal. Alderman Cathcart asked Attorney Erwin if this is the correct way to do this. Attorney Erwin stated that it is common to give employees an option to appeal negative actions taken against them.

Attorney Ewin read the current statute on the records. Mayor Horton stated that this Resolution will be sent to the State Legislature for their approval and then they will change it in the RS Code if they agree. This will be effective next year in their regular session.

#### 2. **RESOLTION 17 OF 2024**

Stephanie Collier explained to the council that the state denied the original adoption of the millage due to the wording on the agenda. Using the words consider is not clearly stating the councils intent to adopt.

ORDINANCE 593 OF 2024: SEWER RATES Introduce and set for public hearing

AN ORDINANCE TO AMEND ORDINANCE 505 OF 2013 BY AMENDING THE RATE SCHEDULE TO BE CHARGED FOR SEWER SERVICE PROVIDED BY THE BENTON SEWER SYSTEM TO CONSUMERS INSIDE AND OUTSIDE THE CORPORAL LIMITS OF BENTON

**BE IT ORDAINED BY** the board of aldermen of the Town of Benton, Bossier Parish, Louisiana, in regular session convened, to amend Ordinance 591 of 2013 by amending the rate schedule to be charged for sewer service provided by the Benton Sewer System to consumers inside and outside the corporal limits of Benton,
