She reviewed the General Fund financials which included the ARPA funds and the 1978 Sales tax fund. She stated that the sales tax funds have gone flat, but this trend is Parish wide not just the Town. She moved on to the Enterprise Fund and discussed the need to increase the rates of the water and sewer due to the increasing costs of operations and expenses. Mrs. Case reported that the Town needs to increase water and sewer rates to break even in the Enterprise Fund but overall the Town is financially consistent.

Mayor Horton called for any questions from the Council. None were made moving on to scheduling a Workshop for July 22 to discuss the South Wastewater system and the different options to consider relating to outside sewer.
