



SHIPPED SEMEN STALLION SERVICE CONTRACT

This certifies _____, herein referred to as the Mare Owner, has engaged one breeding to:
JESS MY MOON for the **2021** breeding season at **\$1250.00** for the following mare: Mare Name: _____ Breed _____

Keyser Creek Arena, agent for the above named stallion will herein be referred to as Breeder. The service is engaged subject to the following:

1. This contract is good for one foal. Multiple foals from the same mare in the same breeding season will require a separate contract and breeding fee for each resulting foal. The only exception to this would be twins that are carried throughout term and foaled by one mare.
2. A non-refundable booking fee of **\$250.00** from the above breeding fee is payable with this contract and the balance of **\$1000.00** plus the service charge for one shipment and the container deposit are due before any semen will be shipped.
3. A **photocopy** of the **registration papers** shall be sent to the Breeder **with this contract**.
4. Shipping days will be: **February 1 – June 30** – Mon, Wed & Fri. We highly recommend sending your mare to a vet clinic or breeding farm for her heat cycle. They will coordinate optimum shipping times with us.
5. Montana Equine must be notified no later than 10:00 AM Mountain Time on the day before the shipment is to be sent. Semen will be shipped on collection days only on an "as available" basis. Mares sent to Breeder will receive preference for semen availability. We try to ship 2 doses of semen with each shipment. However, we do not guarantee 2 doses on all stallions especially during the height of breeding season.
6. Shipped semen service charges will be as follows: (1) U.S. lower 48 states – shipped Federal Express Priority Overnight at \$300.00 per shipment A box deposit of \$40.00 will be charged. It will be refunded to mare owner after containers is returned. Mare Owner is responsible for returning container to the breeder at Mare Owner's expense within 5 days. If the container is not back in our office in 5 days the \$40 deposit will not be returned to Mare Owner. All charges must be paid prior to each shipment. **Keyser Creek Arena is not responsible for shipments once the container has left our hands.**
7. The breeding season in force for this contract shall begin February 1st and close June 30th of the year on this contract.
8. Live Foal Guarantee: Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if foal is stillborn a return season is guaranteed for the following year only, providing proper notification is given. Proper notification is a written certification by a licensed veterinarian within seven days that the mare has slipped, or produced a non-viable foal. Mare owner certifies that such abortion or death did not result from any act or omission of the Owner.
9. If the above named mare should die during breeding season, then the Mare Owner may substitute another mare that is agreed to by both the Mare Owner and Breeder.
10. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of foal.
11. All Fees must be pre-paid prior to shipment of any semen.
12. This contract is governed by the laws of the state of Montana. All accounts are due and payable in Stillwater County, MT in U.S. Dollars.
13. **This contract is not valid unless completed in full. When Mare Owner signs and returns the contract and booking fee to Breeder, Breeder will notify Mare Owner within 10 days of approval. Upon notification, it will become a binding contract on both parties, subject to the above terms and conditions.**
