Other food vendors are prohibited from vending any BBQ food items. If you have questions regarding this, please contact us "prior" to submitting your application.**

- ~ Completed and signed "BBQ Bash Food Vendor Application"
- ~ Signed "BBQ Bash Food Vendor Agreement" AND signed "Waiver of Liability" box at the bottom of the page (both must be signed)
- ~ List of all proposed menu items you plan to sell
- ~ At least 1-2 photographs of your rig / booth set-up (2019 vendors do not need to submit these, unless your set-up has changed)
- ~ Copy of your current Business License
- ~ Insurance Certificate with rider listing Almost Heaven BBQ Bash, Inc. AND Stonewall Resort / Benchmark Hospitality as additional insureds (minimum of \$1 million dollar liability) **** We MUST receive this certificate NO LATER THAN May 15, 2021.**
- ~ Application / booth fee - \$300.00 (\$250.00 vendor fee and \$50.00 Lewis Co. Health Dept. permit fee)
- ~ Applicable fee(s) for upgraded electric or extra space, if needed
- *** BBQ Competitors/Vendors need only pay for electric / extra space once on your team application
- ~ Completed Lewis County Health Dept. permit application (Inspector will issue permits during his on-site inspection).

NOTE: If you have a current Lewis County or WV State Health Dept. permit, you may submit a copy of that in lieu of this

NOTE: Vendors must adhere to ALL State and Local Health Dept. / Covid-19 guidelines in place at the time of the event. Failure to do so will result in the vendor being removed from the event, and not allowed to participate in future events.

*** **2021 BBQ Bash Food Vendor Agreement** ***

June 18-19, 2021

1. **Vendor Space:** Vendors must provide dimensions of their space requirements, and fit in requested space. We will do our best to place vendors in high traffic areas based on your space, electrical, and other needs.
2. **Health Permits:** Vendors preparing food "on site" must complete a Lewis County Health Dept. permit application and return to us **BY April 1, 2021**, along with the required \$50.00 fee payable to Almost Heaven BBQ Bash. We will submit all applications to the Health Dept. at one time with the appropriate fees, and your permit will be issued during your site pre-opening inspection. *** If you are already registered with the Lewis County Health Dept., we will need a copy of your permit for our files, and a copy of that permit must also be prominently displayed at your vending site during the event.*
3. **Insurance:** All food vendors, regardless of your products, must provide a copy of your general liability insurance certificate identifying the "Almost Heaven BBQ Bash, Inc." AND Stonewall Resort / Benchmark Hospitality as additional insureds for a minimum of \$1 Million Dollars coverage. **** We must receive this certificate no later than May 15, 2021 ****
4. **Set-Up / Operating Hours:** Commercial food vendor spaces may arrive to set-up AFTER 2:00 PM Thursday, June 17th and should be ready for health inspections by 9:00 AM Friday and open to the public from Noon – 8:00 PM. All vendors MUST be open by 11:00 AM Saturday and should remain open until at least 6:00 PM. Vendors are responsible for providing all equipment needed to operate their site. Almost Heaven BBQ Bash assumes no responsibility for any property of any vendor.
5. **Visible Pricing:** To expedite ordering and customer service, a priced menu should be visibly posted for the public.
6. **Grease, Oil, Trash, Gray Water:** Designated receptacles for each of these items will be located in the food vendor area. Disposing of these in any other manner is strictly prohibited. Any vendor failing to completely clean their vending area by disposing of ALL trash and other materials in the proper containers will NOT be invited to future events.
7. **Vendor Fees:** A vendor fee of \$250.00 (for Fri. & Sat.) and \$50.00 for health dept. permit (total of \$300.00)
8. **Relationship to Vendor:** Vendors are independent contractors and not considered as an agent, employee, or representative of the Almost Heaven BBQ Bash, Inc. in any way whatsoever.
9. **NSF Fees:** There will be a \$25.00 charge for returned checks from the vendor's bank for non-payment.
10. **Space Assignment:** The Almost Heaven BBQ Bash committee will make every effort to provide the best space to each vendor based on your space/power requirements, and any other requirements. Vendors will NOT attempt to provide samples or sell to customers beyond their assigned vending space.
11. **Tear-down / Site Evacuation:** Vending sites must be completely cleaned and vendors must vacate the venue by 10 AM Sunday, June 20th.

12. Vendors agree to adhere to ALL State and Local Health Dept. / Covid-19 guidelines in place at the time of the event.

Signing below affirms that I have read and will adhere to all of the above regulations. I also understand that failure to comply with any of these regulations may result in my eviction from the event with NO refund of any fees paid.

I/we also grant full permission to the Almost Heaven BBQ Bash, Inc. to use any photographs, video tapes, motion pictures, recordings and any other record of this event for any legitimate purpose. I agree to the terms of this Waiver of Liability, and will abide by the rules of the event and all KCBS rules. Acceptance of all entries is based on a first come basis, however, Almost Heaven BBQ Bash, Inc. reserves the final right of refusal to any and all teams. There is no "Rain Day" schedule for this event, and if required, the event may be cancelled in whole or in part by Almost Heaven BBQ Bash, Inc., with no cash refunds, however we will provide free entry to the following year's event to fully paid, registered teams in the event of an unforeseen cancellation. I have read & agree to adhere to all the rules and regulations of the KCBS and Almost Heaven BBQ Bash, Inc. and understand that failure to adhere to these may be cause for immediate, non-negotiable expulsion from the event with no refund.
