### **MINUTES/SECRETARY'S REPORT**

• Minutes from the May 1, 2019 meeting were reviewed Motion by President-Elect Simmons to accept the May 1, 2019 minutes, 2<sup>nd</sup> by Member Kelly Motion Carried

### **TREASURER'S REPORT**

- Treasurer Thomas reported the balance as of 5-31-19 was \$24,381. Her report shows a balance of \$23,681.55 as two checks had been cashed since 5-31-19. There is one outstanding check for \$460 for Wexford-Missaukee Career Tech Center for the flowers
- President McKee noted that the invoice for printing should be Kellogg College not Holly McKee. Treasurer Thomas will correct
- It was noted that MOSPA has not received check from Ferris State and once that is received Treasurer Thomas will pay the Boyne Mountain bill
- State Liaison Price is working with Mott Community College regarding the money from TIA. It was noted that the money cannot be held by TIA nor be distributed to MOSPA due to being a non-profit organization, therefore Mott Community College is the fiduciary. MOSPA will invoice Mott Community College
- Boyne Points for 2018 were 28,899 and cannot be applied to an organization it was agreed upon in the May meeting that they would be applied to President McKee's Boyne account and

then withdrawn. Treasurer Thomas noted that when they withdrew they had to round up to 29,000 (\$1450). Thank you to President McKee for her donation of points *Motion by Member Cortese to accept the Treasurer's report, 2<sup>nd</sup> by Member Boss Motion carried* 

# **STANDING COMMITTEE REPORTS**

## **CONFERENCE COMMITTEE REPORT**

• President McKee asked that the report be included in the Conference Committee meeting that will follow this meeting as most members are involved

### WEBSITE REPORT

- Member West reported she has completed many updates, has added slide show of photographer pictures and shared speaker information and the dates for next year's Conference
- Member West asked for a PDF copy of the program brochure so she can upload, President McKee will forward that to her
- Member West also request that pictures of award winners be as single shot of them, otherwise she has to do a lot of cropping, this would save her time. President McKee said we will just need to inform the photographer next year
- Member Jackson will forward a copy of the Constitution and By-Laws to Member West to post on website and to Secretary Ganssley so she can forward to the Board Committee Members as well
- It was suggested that under the website report social media will be added
- Member Jackson has also developed a Facebook and will share more information as it comes along

### **AWARDS REPORT**

- At-Large Rep Pollard has agreed to continue with this position for next year and will work on the 2020 Awards. Her committee with consist of President- Elect Webster, Treasurer Thomas and Member Boss. If more are needed she will inform Board
- Secretary Ganssley said she had concerns about the Awards Committee not receiving all the nominations this year with Member Compson leaving. She knows from her region nominations were sent with no confirmation so is sure others got missed. Member Jackson said she has been working with Member West to set up a MOSPA email, this would eliminate this issue in the future

## **MDE and TIA UPDATES**

### Secondary (MDE)

- State Liaison Felder provided a draft copy of the agreement between MOSPA and the Office of Career and Technical Education for the Breaking Traditions Scholarships. Suggestions were made regarding some of the language (check will be available at the ceremony, 2 representatives, one from secondary and one from post-secondary, change from August 1 to October 1)
- State Liaison Felder will revised the agreement and forward to Secretary Ganssley to share with Board. She extended thanks from Dr. Pyles for our support
- President McKee reminded Board the two scholarships will be \$250 each one for secondary and one for post-secondary
- State Liaison Felder stated there are several winners but categorized in different levels. The top level receipts will receive the scholarships

#### Post-Secondary (TIA)

• State Liaison Price reported that there has been an Executive order from the Governor's Office that the Workforce Agency will no longer be existence, it will now be Labor and Economic Opportunities. She is unsure what this reorganization means but will keep Board updated

### **UNFINISHED BUSINESS**

- Term of Expiration for Executive Council discussion of putting terms on the website, they are as follows starting the 19-20 year. President, President- Elect, Past President and At-Large Representative terms are from 2019-2021. Secretary and Treasurer are 2018-2020 and Conference Chair 2019-2020
