LFEHOA Year To Date Financial Information

- Operating Budget: Forecast to end CY 2024 on target.
- **2024 Homeowner Dues:** 100% (115 H/O) Paid.
- Financial Audit: LFEHOA successfully passed the Financial Audit for CY 2023. Audit was performed on August 17, 2024 by committee members Joe Pan and Sandra Munsey. There were no major or minor findings. Great job by Debbie Brothers. All documentation was well organized and detailed which made the audit review flow seamlessly.

This year the open positions are for President, Secretary, and Contracts Administrator. No doubt you all must have noticed some construction around our front entrance.

Not too long ago we received news that the city's demolition of our front entrance would occur sooner than anticipated. Thanks to the quick action and dedication of a small team, we were able to salvage many of our beloved mature plants and our light post.

A special thanks to John Thompson for his invaluable expertise and to Dick Lopes, Gary & Jennifer Schroder, Duane & Charmaine Morris, Louisa Mazziotti, Jody & Blake Carder, Dave Briggs, Sandra Munsey, and Michele Bristow for their tireless efforts on behalf of this community endeavor.

Charmaine and Duane, our 2 newest volunteer members, stepped up to the community ask, we need help. Charmaine's knowledge of plants, love for gardening and great organizational skills, facilitated the development of a very detailed plan for the transplant process.

T-45 Project Update

- Proposed Improvements: Widening SR 169 to provide one additional lane of traffic in each direction, sidewalks and raised bike lanes on both sides, street lighting and two roundabout intersections.
- Purpose: To improve traffic operation, safety, access management and non-motorized amenities in the vicinity of the Legacy Site between SE 253rd Place and SE 260th Street.
- Construction Start Date: 8/19/2024
- Estimated Completion Date: Spring 2026.

Communication between the city of MV and LFEHOA has been continuous. The 169 committee members are in contact with the city on a weekly, sometimes daily, basis and when necessary have met on-site with city engineers and contractors to demonstrate and address issues in real time. For example, impaired sightlines for those exiting and entering LFE; right hand turns from 253rd south on 169 being too tight and putting in temporary lighting after removing our light post. Many of you have also written directly to the city to express your concerns and as a result, corrective action was taken. Safety remains a top priority throughout this project, and we encourage all homeowners to notify us if you have any questions.

SR 169 and all side streets will continue to remain open to traffic while this work is being completed, but please anticipate delays.

October Festival!!!!


October Festival - October 27, 2024
