- 8. Discuss, consider, and take action on current and proposed facilities owned or maintained by the District, including:
  - a. Reimbursements to the Belvedere HOA under the Joint Maintenance Agreement; and

- b. Landscaping of Amenity Center Lot improvements and other facilities.
