3. Discuss, consider, and take action as necessary concerning report from the District's Bookkeeper and Finance Committee, including:
 - a. Payment of invoices;
 - b. Coordination on bookkeeping matters; and
 - c. TexPool investments.
4. Discuss, consider, and take action regarding report from the District liaison to the Belvedere Homeowners' Association ("HOA") and from the HOA liaison to the District.
5. Discuss, consider, and take action to adopt resolution adopting new election equipment for May 2, 2020 Director Election. - 13. Discuss, consider, and take action regarding action items from legislation passed in the 86th Regular Session of the Texas Legislature.
