## WAIVER AND RELEASE AGREEMENT

**This is a release of liability and waiver of certain legal rights**

In consideration for my being permitted to participate in the activities of Epic Graphics, I agree to the following Waiver and Release:

I acknowledge that kayaking has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. Water hazards in boating and wading in the rivers including drowning;
2. Injuries from fishing equipment and other participants;
3. Encounters with wildlife, animals, and insects;
4. Temperature extremes;
5. Inclement weather conditions and unavailability of immediate medical attention in case of injury.

I understand the risks, hazards, and dangers of boating and have had the opportunity to discuss them with Epic Graphics. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

I have been instructed that **I am not to go beyond the Noyo Bridge**, the kayaks are for river use only. I have also been instructed to not enter the Noyo Mooring Basin where the boats are docked. *Initial* \_\_\_\_\_

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Epic Graphics, their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of Epic Graphics or from some other cause.
