



## Schedule of Fees

---

<b>Initial consultation</b>	<ul style="list-style-type: none"><li>• Initial psychiatric evaluation, diagnosis, and treatment recommendations.</li><li>• One (1) hour.</li><li>• \$325</li></ul>
<b>Basic follow-up</b>	<ul style="list-style-type: none"><li>• Basic follow-up appointment for medication management.</li><li>• Twenty (20) minutes.</li><li>• \$125</li></ul>
<b>Complex follow-up</b>	<ul style="list-style-type: none"><li>• Complex follow-up appointment for medication management.</li><li>• Thirty (30) minutes.</li><li>• \$150</li></ul>
<b>Medication management with psychotherapy</b>	<ul style="list-style-type: none"><li>• Medication management and psychotherapy session.</li><li>• One (1) hour.</li><li>• \$200</li></ul>
<b>Phone consultation</b>	<ul style="list-style-type: none"><li>• Brief telephone consultation for urgent matters.</li><li>• 5-10 minutes. Longer conversations require an appointment in person.</li><li>• \$50</li></ul>
<b>Completing medical forms</b>	<ul style="list-style-type: none"><li>• \$50 per ten (10) minute parts per hour.</li></ul>
<b>Medical records request</b>	<ul style="list-style-type: none"><li>• \$10 processing fee plus \$0.10 per page copy fee and postage.</li></ul>
<b>Medication refill (other than at time of appointment)</b>	<ul style="list-style-type: none"><li>• In general, a medication prescription requires an appointment in person.</li><li>• We may elect to provide a refill of medication over the phone, in an amount sufficient to last until an appointment.</li><li>• \$50</li></ul>

**Missed/Late appointment**

- Full fee for all missed appointments or cancellations without twenty-four (24) hours' notice.
- We may elect to excuse a missed appointment or cancellation for illness, family emergencies, and other reasons, at our discretion.

---

**Returned check fee**

- We reserve the right to charge a processing fee for a check that is returned for insufficient funds.
- \$50

---

**Court testimony**

- If we are required to provide court testimony for any reason.
- \$400 per hour.
- Billed in fifteen (15) minute parts per hour.

---

**Overdue balance**

- Interest charged on any balance remaining unpaid thirty (30) days after initially billed.
- Twelve percent (12%) annual percentage rate.

---

**Collections**

- For collections of overdue balances, we reserve the right to collect accrued interest, court costs, and attorneys' fees, as permitted by law.
