

# NADAC Trial: May 19-21, 2023

## Cedar City, UT



### DIRECTIONS TO FACILITY

**Diamond Z Arena**  
**11 S Cross Hollow Dr.**  
**Cedar City, UT 84720**

- **From I-15 South:** Take Exit 57 for UT 130. Keep left at the fork and merge onto Cross Hollow Road and continue for 2.4 mi to Diamond Z Arena.
- **From 1-15 North:** Take Exit 59. Continue on UT-56 W. (W. 200 N.) Turn left/west onto Cross Hollow Road for 2 miles.

### TRIAL INFORMATION

If you need assistance or have questions, please ask any of the SUDS trial representatives. We want to make sure you enjoy your experience at our trial. Please drive at a safe speed, stay, and park within the designated areas. Setup is available indoors on cement or in the dirt arena, so canopies are not necessary. We do recommend you maintain safe distances and avoid congregating for extended periods in tight spaces.

- **Friday:** Exhibitors may begin setup at **08:00am (Exhibitors may arrive anytime for an RV site, but NO setups on Thursday.)**
  - Briefing will begin at 09:45am – we do recommend all exhibitors read the [NADAC Overview](#) that is posted on our trial secretary website [RinoAgility.com](#) and save this [link](#) to view course maps and trial results, etc. Results will be posted online, not printed. Individual results will be sent out after the event as well.
  - **First dog on the line at 10:00am on Friday.**
  - Note for workers/volunteers; we need and really appreciate your assistance throughout the event. Helping with setup and breakdown, plus volunteering in the ring helps keep the trialing moving!
- **Saturday/Sunday:** First dog on the line at **09:00am.**

There will not be a formal **check in** process. We do ask that each exhibitor check their dog(s) in on the gate sheet which will be posted before each class. Don't forget to validate information on your confirmation and email [RinoAgility@gmail.com](mailto:RinoAgility@gmail.com) before the trial if there are any corrections needed.

If your dog needs to be **measured**, you must ensure this takes place **prior** to your first run. The judge or a trial representative will be available prior to the morning walk throughs each day. We'll be happy to assist you throughout the day if you aren't arriving for the first class, but please don't wait until the last minute as we will need to work you in around the trial and judge's schedule. Come by the trial secretary table for assistance. Before getting measured you will need to fill out the "[Application for Permanent Height Card](#)" form. (We can also provide a blank form at the trial.) Note: If your dog is jumping 20" or you entered in the Skilled category you do not need to be measured.

## FOOD

**Please Note:** Minor change about the concession stand and food. The arena has a contract with a different vendor who will be there with two concession stands and a food truck. The arena is **no longer** allowing food to be offered and set out in the arena, like the coffee and donuts that were planned and stated in the premium. The vendor will, however, have those available and SUDS will provide tickets at the event for a complimentary coffee, free refills, and a donut from the vendor.
