Please note we will be incorporating Federal, State, Local and NADAC COVID-19 safety measures and adjustments may be made during the event as trial committee deems necessary. An additional COVID-19 Waiver is attached at the end of premium and is required for anyone that will be onsite at the facility. *Please limit guests as they must be counted if onsite and impact our entry limits*.

Facial covering must be worn at all times, except when running your dog on course, and social distancing must be maintained. Wash your hands frequently, don't touch other people's dogs. Most importantly stay home if you are ill and/or have recently been exposed.

Trial results will **not** be posted at the event, they will be published on the RinoAgility.com website so exhibitors can access them during the trial. Individual results will also be emailed to each competitor after the event.

Crating available:

Plenty of crating available on dirt, some under cover and there is also a grassy area available.

Please ensure approximately 10' between setups (This is about the size of one canopy)

Entry Limits:

This trial is limited to 500 runs per day.

We are limited to 30 Exhibitors at a given time, so entries will be prioritized by first received and highest number of runs. We will make every effort to get as many people into the trial as possible.

Move ups:

Move-ups will be accepted from day to day. No same day move-ups.

Day of Show Entries:

No day of show entries. Adding runs is allowed.

Refunds:

Full refunds will be issued for cancellations prior to closing date.

Cancellations after the closing date for bitches in season, injured dogs, or persons withdrawing due to COVID exposure and/or illness after closing may be subject to an administrative fee.

There will be no refunds for entries withdrawn after the pre-closing (Monday prior to the trial) or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.

Entry fees will be refunded if the trial must be cancelled. If trial proceeds and cannot be completed by reasons of riots, civil disturbances, fire an act of God, public emergency and act of public enemy, or any other cause beyond the control of the organizing committee then entry fees will not be refunded.

Confirmations:

Will be sent as entries are received.

Food info:

NO Beverages, Breakfast or Snacks will be provided at this event – Please plan accordingly.

Individually Boxed Lunches will be provided Grab and go!

Note:

Alcoholic beverages and smoking are prohibited onsite.

Note:

We are planning to pre-designate timer/scribe. We will not have a gate steward.

Exhibitors will need to be prepared to run when your jump height is set in each class. To minimize need for leash runners, if possible, please plan to carry leash concealed in pack or pocket or bring second leash and drop at designated spot prior to your run.

We will, as always, need help setting jumps!

Awards and Ribbons:

Ribbons will be available, upon request, for all qualifying runs and first through fourth places in all classes except for Chances. Since Chances is a pass/fail game, placements ribbons are not given.

Ribbons will also be available, upon request, for those finishing a title.

Please let the us know if your dog may earn a NATCH or other new title at this trial. We love to help you celebrate!

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will
 not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted.

- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but it cannot be used during your run, nor can you indicate to the dog it is there. Only Intro and Novice handlers my bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the
 possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every
 dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show
 premises.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.
- 1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
- 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), Rino Agility Partners LLC (including its officers, directors, members, and event organizing committee), and City of Yucaipa and Yucaipa Equestrian Center (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

Release and Waiver of Liability

This Release and Waiver of Liability (the "Release"), is agreed to and executed by the entrant into the Rino Agility Partners LLC NADAC agility trial, in favor of Rino Agility Partners LLC (hereinafter "Rino Agility") and The North American Dog Agility Council, LLC, (hereinafter "NADAC"), its directors, officers, employees, agents, representatives, volunteers, members, successors, and assigns, (collectively, "Rino Agility" and "NADAC"). Handler and/or Owner intends to participate in Rino Agility's upcoming NADAC agility trial to which the premium is attached and in consideration of the acceptance of this entry and of the holding of this NADAC event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies/bars, enters into this Release and Waiver in contemplation thereof.

- 1. Waiver and Release. Handler and/or Owner does hereby, voluntarily, and without duress, execute this Release. Handler and/or Owner does hereby release and forever discharge NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, and any NADAC approved judge judging at this event, and other participants at the event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of any dog while in or about the event premises or grounds or near any entrance thereto, from any and all actions, causes of action, suits, debts, liabilities, claims, and demands of whatever kind or nature, either in law or in equity, which have arisen now or may hereafter arise from Handler and/or Owner's participation in the NADAC events. Handler and/or Owner understands that this Release discharges NADAC and Rino Agility from any liability or claim that Handler and/or Owner may have against NADAC or Rino Agility with respect to any bodily injury, personal injury, illness, death, property damage, or any other damages that may result from Handler and/or Owner's participation in Rino Agility events.
- 2. Assumption of Risk. Handler and/or Owner acknowledges and agree that dog bites or other injuries to humans and other dogs do occur, and that all dogs can carry and transmit diseases, including diseases that can be transferred from dogs to humans. Handler and/or Owner understand that NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, will not be responsible for any damage any dog may inflict on any person, another dog, any property, or for the transmission or transfer of any disease or parasite to other dogs or people, and no attempt will be made by Handler

and/or Owner, or anyone on the behalf of the Handler and/or Owner, to hold NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, responsible for such damages. Handler and/or Owner hereby expressly and specifically assumes the risk of injury or harm resulting from Handler and/or Owner's participation in Rino Agility's events.

- 3. Indemnification. Handler and/or Owner agree to indemnify and hold NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, harmless from any and all damages, loss, cost, or liability (including reasonable legal fees and the cost of enforcing this indemnity) arising out of or in any way resulting from Handler and/or Owner's participation in Rino Agility's events, specifically including any and all attorney's fees incurred by NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, incurred in enforcing this Release.
- 4. No Representations. Handler and/or Owner acknowledges and agree that NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, make no representations with respect to any dogs that Handler and/or Owner may interact with while participating in Rino Agility's events.
- 5. Insurance. Handler and/or Owner understands that NADAC, Rino Agility, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, do not carry or maintain health, medical, worker's compensation, automobile, or disability insurance coverage for any Handler and/or Owner. Handler and/or Owner is solely responsible for his/her own care and coverage, should any be desired or needed. Each Handler and/or Owner is expected and encouraged to make arrangements for appropriate insurance coverage prior to beginning participation in the Rino Agility events.
- 6. Photographic Release. Handler and/or Owner agree that NADAC and/or Rino Agility may use images and recordings, whether audio or visual or both, of Handler and/or Owner taken during or in connection with Rino Agility events as it sees fit in its sole discretion to benefit and promote Rino Agility and/or NADAC and Handler and/or Owner does not expect monetary compensation, remuneration, or a fee of any kind in exchange for allowing NADAC and/or Rino Agility to use such images and recordings. Handler and/or Owner does hereby grant and convey unto NADAC and Rino Agility all right, title, and interest in any and all photographic images and video and audio recording made by NADAC and/or Rino Agility during Rino Agility events, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings and Handler and/or Owner acknowledges and agree that all artistic control is in the hands of NADAC and/or Rino Agility. Handler and/or Owner further releases NADAC and Rino Agility from any recourse or action due to the nature or content of this production.
- 7. Termination. Handler and/or Owner acknowledges and agree that Handler and/or Owner's participation in Rino Agility events is a privilege that may be withdrawn at any time by NADAC and/or Rino Agility, with or without cause, and in the sole discretion of NADAC or Rino Agility.
- 8. Signature Binding. Handler and/or Owner acknowledge that s/he has the authority to execute this Release on behalf of any and all other Handlers and/or Owners and that the Handler/Owner signature affixed to the Premium Entry binds any and all other Handlers and/or Owners the same as if signed by all other Handlers and/or Owners.
- 8. Other. Handler and/or Owner expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California, and that this Release shall be governed by and interpreted in accordance with the laws of the State of California without regard to any conflicts of law provisions. Handler and/or Owner agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of

competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable. This document may be transmitted by facsimile, email or similar method, and copies of this document may be relied upon and shall serve as originals. Handler and/or Owner is fully informed as to the nature of this release and Handler and/or Owner hereby represents that he or she has the power and ability to so grant this release. Handler and/or Owner understands that if Handler and/or Owner is approved to participate in Rino Agility's events that this Release shall apply to any and all Programs in which Handler and/or Owner participates.

RV Camping: We encourage you to consider alternatives to RV camping overnight onsite. If your entry is contingent on having a self-contained camping spot, we **may** be able to get approval for a very limited number of RV spaces. Self-contained, if approved, would be \$20 per day. You must pre-register by trial closing date and we will get back to you if we are able to secure approval. Without advance approvals RVs will need to vacate the premises each evening at the end of the event. (Please keep your areas clean and remove your own trash/debris whether staying overnight or just day camping during the event.)
