DIRECTIONS TO FACILITY Yucaipa Equestrian Center 13273 California Street Yucaipa, CA 92399 REMINDER: Please bring payment with you to the trial! Thank you!



- I-10 E take exit 87 toward W County Line Rd, take a left off freeway and continue on W County Line Rd., turn left onto California St. and continue until you reach the Yucaipa Equestrian Center (at California St near Avenue G).
- I-10 W take exit 89 for Singleton Rd, take a right off the freeway and continue on Singleton Rd, keeping left onto Bryant St., turn left onto Ave H., turn right onto California St. and continue until you reach the Yucaipa Equestrian Center (at California St and Avenue G).

COVID-19 SAFETY PROTOCOLS

- An additional COVID-19 Waiver is required for anyone that will be onsite at the facility. Please limit guests as much as possible but be sure to complete and turn in a COVID-19 waiver if they are in attendance.
- Facial covering must be worn, except when running your dog on course or eating. When eating please stay in your own setup area at least 6' from others.
- Wash your hands frequently, do not touch other people's dogs. Hand sanitizer will be available in various places around the site.
- Social distancing must be maintained at all times. Please setup approximately 10' from other exhibitors (10' is about the size of a standard canopy). Avoid grouping together; one person/next dog should be only one waiting at ring entrances.
- Keep course walk throughs to about 10 people at once. There will be plenty of time for everyone to walk.
- A pen is provided in each exhibitor's entry gift pack. Please utilize your own pen to check in at the gate or for other writing needs.
- To reduce the need for leash runners, if possible, we recommend you stow your dog's leash in your pocket, around your shoulder, waist, or in a fanny pack during your runs. Avoid having any of the ends dangling, as this could result in an elimination.
- Trial results will not be posted at the event, they will be published on the RinoAgility.com website so exhibitors can access them during the trial. Individual results will also be emailed to each competitor after the event.
- Most importantly stay home if you are ill and/or have recently been exposed.

TRIAL INFORMATION

If you need assistance or have questions, please ask any of the Rino Agility Partners trial representatives. We want to make sure you enjoy your experience at our trial. Please drive at a safe speed, stay, and park within the designated areas. Setup is available under the covered arena, so canopies are not necessary, but you can be setup outside the arena if you would prefer. We are planning to rotate between two rings, so be prepared for walk thru in one ring while dogs are running in the other. We may overlap some rounds and run in both rings simultaneously if trial is progressing slowly.

Note: This trial we will again have AgilityVideos4You by Alan & Kathy Upton filming runs. No previews or flash drives will be available. You may stop by and verbally tell Kathy what you would like to order, or you can email or text her the information. The videos will be sent to you via Download or YouTube. You can also order online 2-3 days after the trial from their website AgilityVideos.com.

- Friday: Exhibitors may begin setup at 10:00am. (We need time before 10am to designate rings, scorekeeping, & exhibitor areas.)
 - Briefing and Walk Through will begin about 11:00am.
 - Note for workers/volunteers; we need and appreciate your assistance! Equipment trailer is expected to arrive at approximately og:ooam on Friday. Unloading and ring setup will begin shortly thereafter. (Bring gloves/facial covering.)
- Saturday/Sunday: Walk throughs will start at 09:00am.

There will not be a formal *check in* process, but we will be offering a check in gift for each exhibitor entered. We do ask that each exhibitor check their dog(s) in on the gate sheet which will be posted before each class. Don't forget to validate information on your confirmation and email <u>RinoAgility@gmail.com</u> before the trial if there are any corrections needed.

We recommend all exhibitors read the *trial briefing* that will be emailed out prior to the event. Keep in mind it is your responsibility to stay informed and follow all the rules and guidelines.

If your dog needs to be *measured*, you must ensure this takes place *prior* to your first run. The judge or a trial representative will be available prior to the morning walk throughs each day. We'll be happy to assist you throughout the day if you aren't arriving for the first class, but please don't wait until the last minute as we will need to work you in around the trial and judges schedule. Come by the trial secretary table for assistance. Before getting measured you will need to fill out the "Application for Permanent Height Card" form which is available at: http://www.nadac.com/forms/Application-for-Permanent-Height-Card.htm. (We can also provide a blank form at the trial.) Note: If your dog is jumping 20" or you entered in the Skilled category you do not need to be measured.

FOOD
