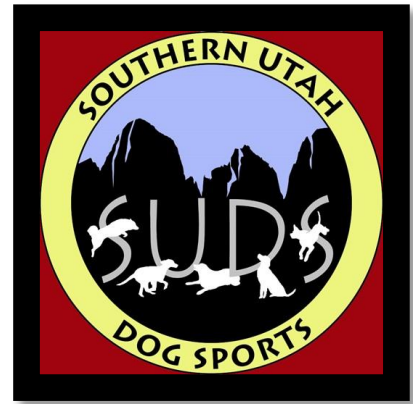


SUDS NADAC Trial: July 17-19, 2026

Hurricane, UT



DIRECTIONS TO FACILITY

Washington County Legacy Park
5500 W. 700 S.
Hurricane, UT 84737

- **From the South:** Follow I-15 N to UT-9 E in Washington. Take exit 16 from I-15 N. Merge onto UT-9 E towards Hurricane. Turn right onto 5300 W. Continue straight onto 5500 W/S Regional Pk Rd
- **From the North:** Follow 15 S to UT-9 E in Washington. Take exit 16 from I-15 S. Merge onto UT-9 E towards Hurricane. Turn right onto 5300 W. Continue straight onto 5500 W/S Regional Pk Rd
- **Notes for finding the arena and parking:** Just past the New Harmony building is the SUDS indoor arena. The indoor arena is near the outdoor horse arena and RV parking. Parking is okay in the dirt lot up near the arena, but please pay attention as there may be horse traffic. Also, we ask that you avoid spots marked as reserved for the judge and trial committee.

TRIAL INFORMATION

If you need assistance or have questions, please ask any of the SUDS trial representatives. We want to make sure you enjoy your experience at our trial. Setup is available indoors, so canopies are not necessary.

- **Friday/Saturday/Sunday:** Exhibitors may begin setup at 07:00 am Friday (Exhibitors may arrive anytime for an RV site, but **NO exhibitor setups on Thursday** – with the exception of the trial committee and those assisting with ring/event setup.)
 - First walk through will start approximately 07:30am (once course is set and approved by judge) – In lieu of onsite briefing we do recommend all exhibitors read the [NADAC Overview](#) that is posted on our trial secretary website RinoAgility.com and save this [link](#) to view course maps and trial results, etc. Results will be posted online, not printed. Individual results will be sent out after the event as well.
 - **First dog on the line at 08:00 am on Friday, Saturday, and Sunday.**
 - Note for workers/volunteers; we need and really appreciate your assistance throughout the event. Helping with setup and breakdown, plus volunteering in the ring helps keep the trial moving!

There will not be a formal **check in** process. We do ask that each exhibitor check their dog(s) in on the gate sheet which will be posted before each class. Don't forget to validate information on your confirmation and email RinoAgility@gmail.com before the trial if there are any corrections needed. SUDS will be providing each exhibitor with an appreciation gift, so don't forget to pick one up at the trial.

If your dog needs to be **measured**, you must ensure this takes place **prior** to your first run. The judge or a trial representative will be available prior to the first class each day. We'll be happy to assist you throughout the day if you aren't arriving for the first class, but please don't wait until the last minute as we will need to work you in around the trial and judge's schedule. Come by the trial secretary table for assistance. Before getting measured you will need to fill out the "[Application for Permanent Height Card](#)" form.

Note: If your dog is under 2 years old they will not need to be measured.

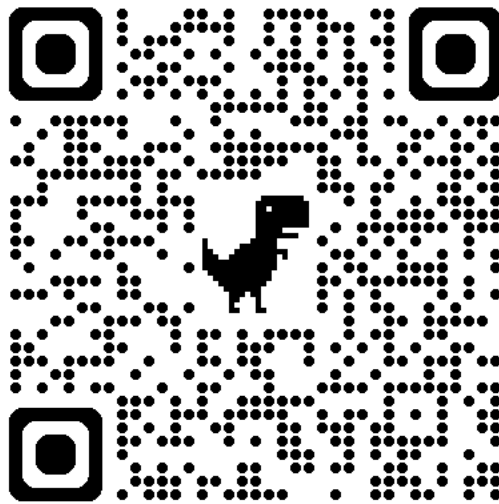
