Thank you for your commitment to quality educational experiences!

The Trenton Educational Foundation was established in 2008 by a group of community leaders who recognized that the quality of an educational system and the vitality of the community it serves are intertwined. The Foundation strives to enhance traditional school funding with private resources in order to provide additional opportunities for students.

Because of our generous donors, we were able to contribute over \$480,000 to our schools and students since 2008. This past year, nineteen \$1,000 scholarships were awarded to students from the THS class of 2022.

The past four years we have provided sixteen New Teacher Grants of \$250 to each new teacher for expenditures on classroom supplies. This fall we had twenty new educators in the Trenton Public School system who received grants.

Also, last year we were able to provide grants for classroom and school projects totaling \$14,885. This included funding Brewing Independence, a fantastic program at Arthurs Middle School that fosters an entrepreneurial spirit in students by providing a business to run and manage serving coffee and snacks to teachers and guests.

Thank you again for your support of the foundation and our Trenton schools, students, and teachers. Without your generosity, we could not provide these additional resources.


