

## Tyrone's Tote Service Seller Agreement

***This agreement must be signed at the time of item drop-off in order to use the Tyrone's Tote Service with Tykes & Teens Consignment (T&T). By signing this agreement, you confirm that you have carefully read and understand the guidelines and procedures and agree to the terms stated below.***

1. Seller agrees to pay the **non-refundable** seller fee before items can be entered into the My Sale Manager System. An additional fee of \$17 will be taken out of the Seller's check at the end of the sale. **INITIAL HERE:** \_\_\_\_\_
2. Seller understands that there is a limit of 200 items per seller number. If you have more than 200 items, you can register for another seller number with the Tote Service. You will need to have another email address to register for a second seller number. This is a My Sale Manager rule and not a T&T rule.
3. Seller agrees to arrive promptly at the special designated drop-off day and time chosen by the seller.
4. Due to limited storage space, sellers will bring their items in non-returnable cardboard boxes or disposable bags. Please indicate your seller number somewhere on the box / bag. Any tubs used for drop-off will be considered a donation to be used by T&T and will not be returned.
5. Tykes & Teens is NOT responsible for damaged, lost, or stolen items.
6. Tykes & Teens reserves the right to reject any item that we deem inappropriate for our sale. This includes items with stains, holes, rips, tears, missing buttons, broken zippers, or smelling of smoke. Or toys with broken pieces, missing pieces, or no batteries. Or non-seasonal items (as per the Seller Instructional Guide).
7. Seller agrees that his/her items have not been recalled or any car seats are past expiration.
8. Seller agrees to fill out the Car Seat Information and History Form for each car and booster seat brought to the Tote Service.
9. If the Seller wishes to have items returned, all items not sold or donated at the end of the sale **MUST** be picked up either the **Saturday** of the sale between 5:00 and 5:30pm or the **Monday** after the sale between 5:00 and 7:00pm. T&T does not have the time to contact sellers during breakdown / item pick-up to check on a consignor. ***If unsold items are not picked up, all items will be donated.***

10. Sellers will receive 50% of the total price of items sold. Seller checks will be given out at your pickup time. Checks will be ready to pick up at the earliest on Saturday between approximately 5:00 to 5:30pm. If you donate your items, you can still pick up your check or your check will be mailed to you at no cost. **INITIAL HERE:** \_\_\_\_\_

11. Seller agrees that all clothes / items are seasonal. Seller agrees that they have looked over the Acceptable / Unacceptable Items list in the Seller Agreement and the items brought to the sale adhere to those guidelines. The Seller Agreement can be found on our website. This list can be updated between sales and the seller agrees they are using the most recent list.

12. All items that require batteries must have working batteries or the item will be rejected.

13. Seller agrees they have no more than 10 pairs of shoes.

14. Seller agrees they have no more than 15 books (books can be bagged or grouped together based on reading level and that will only count as one item).

15. Seller agrees that Members of the T&T Committee, or a volunteer working with a T&T Committee member, can price the items brought to the Tote Service as they deem appropriate. Seller agrees that these prices will generally be between 25-30% of the retail price if worn and 40-50% if like new. Some prices may be higher or lower depending on the item and the quality of the item. **INITIAL HERE:** \_\_\_\_\_
