Based on these discussions supports were put into place for students needing them. The teams will meet on a regular basis to review the progress of each student. The high school administration and staff are to be commended for this work.

#### 2020 Capital Project Update

-Mr. Shaw updated the Board of Education on the presentations that had been given at the meetings at the high school along with the township halls and City of Luna pier. He pointed out that there are more meetings scheduled to answer questions at the school.

#### Thrun Law Board of Education Policies

-Mr. Shaw presented to the Board of Education about moving from Neola to Thrun for their Board Policies. The district many times during the year has Thrun review polices that Neola has written. The Thrun policies have been constructed and reviewed by the attorneys who represent us bringing consistency with policies required by the State and best practices. The initial cost is \$7,000 for the policies and \$4,000 for administrative guidelines with an annual update cost of up to \$2,500. This past year the cost for Neola was \$3,139. The Board requested one or two Thrun polices to be compared with Neola polices for the next Board meeting.
