## Personnel/Leadership

Held our 5th New Teacher Academy Session: This month's topic was Stress Management and Self-Care led by Principal Brandon Bates and Social Worker Don Traviss. Our attendance averages about 5 new teachers per session and the feedback has been wonderful.

## Academics and Programs

- The District is piloting a math interventionist position for the remainder of the year at Central Elementary School.
- Adding Advanced Placement (AP) Physics next year.
- Lourdes University will teach a section of English Comp, English Lit, Sociology, and Politics in the Media here on campus.
- High School students will begin utilizing a personalized learning plan to help guide their requests and career and post-secondary planning towards the end of the month.
- Purchased glasses for all students and staff to prepare for the solar eclipse on April 8th. It is predicted that the eclipse will occur during our elementary dismissal, so we wanted to ensure kiddos had the protection necessary and students at home have protection in the event they go out to look at it. It should last briefly and around 3:12 pm for us.
